



## Meet LLR's Newest Board

There's been a lot happening with the S.C. Board of Landscape Architectural Examiners recently and the following information provides an update on changes to the program.



On June 11, 2010, the Governor signed the first changes to the Board's legislation since 1994. This legislation brings about a number of improvements that will lead the profession into the future with a

stronger program.

The biggest change is a change in name and location. Effective July 1, 2010 the S.C. Landscape Architect Registration Program is now the S.C. Board of Landscape Architectural Examiners, and the program is administered through the S.C. Department of Labor, Licensing and Regulation (LLR). Please make note of our new contact information below.

Be sure to review this newsletter for important information on changes taking place with the program. Additional information will be included in future editions of this newsletter.

Jan Simpson is the new Administrator for the S.C. Board of Landscape Architectural Examiners. She is also the Administrator for the S.C. Board of Architectural Examiners and the S.C. Board of Professional Engineers and Surveyors.

Sherri Moorer remains the Program Assistant with the S.C. Board of Landscape Architectural Examiners and has moved from the S.C. Department of Natural Resources to the S.C. Department of Labor, Licensing and Regulation with the program.

# What Does It Mean? Changes in S.C. Board of Landscape Architectural Examiners Law



In addition to the recent move, there are several changes in the S.C. Code of Laws, Chapter 28, Title 40. Below are the major changes that will affect licensees in this state:

The Board is now established as the S.C. Board of Landscape Architectural Examiners; administered through the S.C. Department of Labor, Licensing and Regulation – Office of Board Services. The Board is no longer with the S.C. Department of Natural Resources.

The S.C. Landscape Architect Advisory Council is now the Board of Landscape Architectural Examiners. This Board consists of five professional members and two members of the general public. All members are appointed by the Governor. The five professional members are in place for the term of July 1, 2010 – June 30, 2011. The public members will be appointed in the near future.

A designation has been created for Emeritus Landscape Architect. Beginning with 2011 license renewals, qualified individuals may apply for Emeritus status. The basic requirements for becoming an Emeritus Landscape Architect are that an individual must be 65 years of age or older, licensed for 10 or more consecutive years, and completely retired from active practice. Look for more information on applying for Emeritus Status when license renewals open in December 2010.

The designation for “firms” has changed. This means a change in who is required to apply for a Certificate of Authorization with the Board. Now businesses that are functioning as a sole proprietorship, partnership, limited liability partnership, professional association, professional corporation, business corporation, limited liability company, joint venture, or any other legally constituted organization that practices or offers to practice landscape architecture must apply for a Certificate of Authorization if the business is advertising or offering landscape architectural services in the State of South Carolina. Individuals operating a sole proprietorship under their own name as licensed by the board are not required to apply for a Certificate of Authorization with the Board. For example, John Smith may operate in his name only, but firm licensure would be required for John Smith & Associates or John Smith, PA.

Requirements to apply for a Certificate of Authorization have changed. There are two changes to the requirements to apply for a Certificate of Authorization in South Carolina. First, the firm must be registered with the S.C. Secretary of State prior to applying for a Certificate of Authorization with the Board. Second, the responsible South Carolina Landscape Architect is no longer required to be a shareholder, partner, or officer with the firm. The firm will qualify as long as the responsible Landscape Architect is a full-time employee. All employees providing landscape architectural services in South Carolina must also have an individual license with the Board.

There have been changes to the requirements for registration. There are still four methods to apply for registration and two methods to qualify to sit for the CLARB – Landscape Architect Registration Examination (LARE) in South Carolina, as detailed below. Please note that Method 2 has changed:

Method 1 – Accredited degree in landscape architecture/two years of supervised landscape architectural experience/pass CLARB – LARE. This requirement did not change with the new legislation.

Method 2 – Non-accredited landscape architecture degree or four-year degree in related program/five years of supervised landscape architectural experience/pass CLARB – LARE. Please note that this requirement

did change with the new legislation. Now all applicants must have at least a four year degree in order to sit for the LARE or to qualify for registration.

Method 3 – Reciprocity. Applicant must hold a license to practice landscape architecture issued upon examination in a state or jurisdiction with requirements substantially equivalent to or more stringent than those of this state. This requirement did not change with the new legislation.

Method 4 – CLARB Certification. Applicant must submit certification documents from the Council of Landscape Architect Registration Boards (CLARB) verifying qualifications for licensure.

The program is moving to biennial license renewals beginning with the 2011 renewal cycle. Please see the “2011 Renewals” article in this newsletter for details on license renewals.

There is a Continuing Education Requirement for license renewals. Beginning with the renewal in 2013, licensees will be required to report 20 hours of continuing education to qualify for license renewal. The Board is working on regulations to implement this requirement, so we’re under a “grace period” on this requirement. Look for additional information in future newsletters.

There is a timeframe to apply for reinstatement of a lapsed license. Licenses can only be reinstated during a period of two years after they lapse. If an applicant wishes to reinstate a license that has lapsed for more than two years, he/she must reapply for licensure and meet the current requirements in the law.

## What about the LARE?



**Beginning in December 2010, Sections C and E of the LARE will be administered at a newly opened CLARB Regional Testing Center in Columbia.**

The regional testing center will make it easier for candidates to sign-up and pay for the vignette sections of the LARE and will allow them more direct access to information and materials regarding the exam from CLARB.

The registration process is now the same for all administrations of the exam. If you wish to take the C/LARE or the LARE in South Carolina, you must submit an application to the Board by the pre-registration deadline in order to be added to the South Carolina Pre-Approved Candidate List. Once on this list, you will be allowed to continue your registration through CLARB, to make payment and to sign up for your testing site.

Administration dates and pre-registration deadlines for the C/LARE and the LARE through the end of 2011 are in the chart below:

## 2011 License Renewals



Licenses for individual landscape architects and for Certificates of Authorization must be renewed with the Board office by Jan. 31, 2010. Any renewals received after the Jan. 31 deadline will be subject to a late fee.

There are several changes that will be taking place with license renewals for 2011:

1. License renewals will be biennial beginning with this renewal cycle. The renewal period will be extended by one month at no charge. The new renewal deadline is Jan. 31, 2011. If you choose to renew your license, it will be valid Feb. 1, 2011 – Jan. 31, 2013.

Since licenses will be renewed for a two-year period, the renewal fee will increase. The renewal fee for individual landscape architects will be \$200 and the renewal fee for Certificates of Authorization will be \$400.

You will be able to renew your license online. Online renewal forms will be available through LLR's website on Dec. 1, 2010 when license renewals officially begin. You may pay your renewal fee by online check, MasterCard, or Visa.

ID cards for individual licenses and the Certificate of Authorization will be mailed within three business days of receipt of your renewal form and fee.

Reminder notices and delinquency notices will not be mailed from this office. The information that you receive regarding your license renewal during the first week of December will be the only notice you will receive regarding your license renewal. *It is your responsibility to renew your license by the January 31 deadline.*

There will be no grace period on late renewals. *Renewals that are received in this office after the January 31 deadline will be subject to the late fee, regardless of the check date or the postmark date on the envelope.*

Look for a notice in your mail the week of November 29 with details on the new process for renewing your license.

## Emeritus Status

Are you a landscape architect who is?

- Over 65-years-old
- Licensed for 10 consecutive years or longer
- Completely retired from active practice

If so, then you qualify to apply for Emeritus Status.

Emeritus Status is a new licensure designation for individuals no longer practicing landscape architecture but who still wish to use the title “Emeritus Landscape Architect.” Other advantages are:

- No license renewal fees
- Exemption from the Continuing Education requirement (once it is implemented)

If you are interested in applying for Emeritus Status, return your 2011 Renewal Form to the Board office and check “I wish to apply for Emeritus Status” on the form. The Board will contact you with additional information once the form is received. Remember, you cannot practice landscape architecture in any manner while in Emeritus Status.

## All Employers Must Comply with S.C. Immigration Act by July 1, 2010

The “South Carolina Illegal Immigration Reform Act” that was signed into law by Governor Mark Sanford on June 4, 2008, is applicable to all businesses in South Carolina regardless of the number of employees.

Compliance with this law began July 1, 2009, for private employers who employ 100 or more employees. For private employers who employ less than 100 employees, the compliance date is July 1, 2010.

The law requires all employers to verify the legal status of new employees and prohibits employment of any worker who is not legally in this country and authorized to work. The South Carolina Department of Labor, Licensing and Regulation’s Office of Immigrant Worker Compliance is charged with investigating complaints and conducting random audits of private employers to assure compliance. Failure to comply can result in severe monetary penalties and revocation of an employer’s right to operate their business.

During the first year, LLR investigators found that most large employers (more than 100 workers) were in compliance with the law. When violations were found they generally were because

- employers who were using E-Verify to verify their employees, did not do so within the five-day timeframe required by the law.
- employers who were using driver’s licenses to verify employees, did so using a driver’s license from a state not on the approved list.
