**Board Policy on Unlicensed Practice:** The Board reviewed the policy on unlicensed practice.

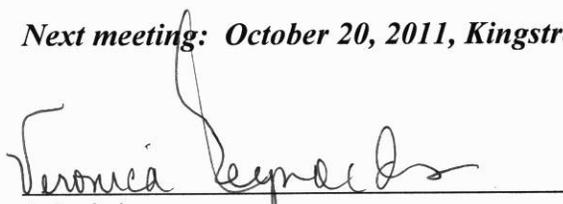
