Meeting called to order at 10:26 a.m., opening remarks by Chief Zubia, then comments made by Randy Battle, former Chairman. Mr. Battle asked that everyone introduce themselves.

Election of new officers:

- Mr. Richard O'Sheal, Chairman
- Mr. John Butcher, Vice Chairman

Minutes - approved from previous LP Gas Board meeting, Mr. Lucas motion to approve, Mr. Segars seconded. Minutes were unanimously accepted by the Board.

New Business – Policy & Regulations issues were discussed. Chief Zubia discussed the Engine bill – no action taken at this time. Chief Zubia also discussed LP Gas Regulations and Mr. Spoon explained “clean-up” of the regulations. Mr. Freeman motioned to accept the changes to Chapter 71 as outlined. Mr. Tindal seconded. Motion unanimously accepted by the Board. The Code issues were also discussed by Chief Zubia, Mr. Tindal motioned to approve changes as presented. Mr. Segars seconded. Motion unanimously accepted by the Board.

LP Sites and parking of tank vehicles were discussed. It was suggested that a sub-committee be formed to deal with all fire code issues.

Mr. Freeman asked permission of Chief Zubia to disperse draft document. Mr. O'Sheal approved.

Mr. Freeman also made a motion to create a task group to continue work on the IFC codes. Mr. Butcher seconded. Volunteers for task group include: Mr. Freeman, Art Irick, Bill Galloway, Anthony Segars & Jerry Tindal (and staff).

Chief Zubia discussed on-going investigations, cease & desist orders. Mr. O'Sheal approved for Chief Zubia to sign the orders and requested that staff provide all board members copy of the cease & desist orders, not just to Chairman.

Chief Zubia discussed no storage facility requirement and regulation process.

Corky Clark has requested that Errata be published in the next State Register. He also mentioned the conflicting code adoption.

Motion to adjourn by Anthony Segars, John Butcher seconded. Motion was unanimously accepted by the Board. Meeting adjourned at 12:02 pm. Next meeting scheduled for January 24<sup>th</sup> .....
