All revenue collected, except for Firework License (\$55,595), Explosive Use Permit (\$48,525), Labor Safety Act Fine(\$329,494.88) and Wage Claim Violation Fine(31,143.82) revenue (which is deposited to the general fund), is used for the general operations of the agency, including personnel, employer contributions, operating expenses, equipment and maintenance.

Proviso 81.3 directs LLR to transfer an amount equal to 10% of the expenditures in Program II.F. Professional and Occupational Licensing and all revenues above expenditures from the Contractor's Licensing Board to the General Fund. In FY19, the amount remitted to the General Fund was \$1,872,407.38.
