All revenue collected by the agency is used for the general operations of the agency to include the following: Personnel, Employer Contributions, Operating Expenses, Equipment and Maintenance.

Proviso 81.3 (LLR: POLA - 10%, Other Funds) directed LLR to transfer an amount equal to 10% of the expenditures in Program II.F. Professional and Occupational Licensing and all revenues above expenditures for the Contractor's Licensing Board. In FY15, the amount remitted to the general fund was \$2,068,839.48.
