## a. Legislative Update - Holly Beeson

Ms. Beeson provided Council members with an update on the current legislative session and bills that have been introduced so far. Her report included updates about bills 3334, 3493, 3607, 4086, and 4224.

## b. Council Executive's Report- Maggie Smith

Ms. Smith provided cash reports for both the Building Codes Council and the Certification Program; and provided licensure statistics to the Council, citing 25 newly issued registrations and three newly issued licenses as of October 23, 2023, with a total of 1,128 active licenses and registrations. Ms. Smith also reviewed the Council-approved code adoption timeline for the 2024 code adoption cycle, and reminded the Council that preparations have begun to nominate the Code Study Committee.
