AARO Annual Meeting Update \_ Mr. O"Brien reported that he and Mr. Pitts attended the AARO Conference which was held October 10-13, 2009. The meeting was very informative and topics of interest included:

- The Board Members Manual Mr. O'Brien reported that the manual included the duties and responsibilities of Board members. He reported that this would be a good tool for new Board appointees to review.
- Voluntary Disciplinary Action Matrix Mr. O'Brien reported that Voluntary Disciplinary Action Matrix would be a good tool to use as guidelines for any future disciplinary actions. The Board was in favor of formalizing the Voluntary Disciplinary Action Matrix in early 2010.
- AMC Legislation Mr. O'Brien reported that the following States have adopted the AMC legislation: Utah, Arizona, Nevada, Louisiana, California and New Mexico and the following States are pending legislation: North Carolina, Hawaii, Minnesota, Missouri and Alabama. California signed to regulate AMC's legislation but the bill has no body, fees and regulations. The Board decided to appoint a task force consisting of Chairman Sass, Mr. O'Brien, Mr. Pitts and members of the Appraisers Institute and SCPAC to establish a statement addressing the Board's opinion regarding the AMC legislation and have it distributed by December 15, 2009. The statement will be published on the website, sent via-email and sent to the associations.

Mr. Johnson reported that it is imperative for appraisers to work within their jurisdictions and locations of where they live when doing appraisals.

<u>Draft Guidelines for disposition of complaints concerning infractions in other state jurisdictions</u> – Mr. Plunkett presented draft guidelines for disposition of complaints concerning infractions in other states. After review, the Board decided to table the approval of the guidelines until reviewed and approved by the Office of General Counsel.

<u>Appraisal Subcommittee Update-</u> Mr. Beau Tiller reported that Appraisal Subcommittee Staff conducted an ASC Compliance of the Appraiser Regulatory Program on May 12-14, 2009. The ASC considered the staff's preliminary findings regarding the Review and the State's response.

- The ASC staff found that the Board uses a point system for determining experience hours and has never required applicants to provide actual number of hours per assignment. On July 10, 2009, the Board reported, appraisers are required to provide the actual number of hours they worked on each appraisal assignment on their experience log.
- The ASC staff found that due to a department directive, cases considered as "Do Not Open" were being destroyed after one year. On July 10, 2009, the Board reported that case files that were considered "Do Not Open" would be maintained and not destroyed until ASC staff has had an opportunity to review the files at the next compliance review.

The ASC determined that South Carolina's Program appeared to be in substantial compliance with Title XI of the Financial Institutions Reform, Recovery, and Enforcement Act of 1989, as amended.

<u>Board Member Retreat</u> – Mr. Pitts recommended that the Board have a Board Member Retreat offsite before the next scheduled meeting. He asked the members to review their calendars to check their availability for January 2010.
