APPRAISAL MANAGEMENT COMPANY NATIONAL REGISTRY

The South Carolina Real Estate Appraisers Board (Board) will be collecting the national registry fees from Appraisal Management Companies (AMCs) as required by S.C. Code Ann.§§40-60-360(B) and (C) (1976, as amended).

In order for a state's AMCs to provide services in connection with federally related transactions (FRTs), and be included on the ASC's AMC National Registry, the state must participate in AMC registration and supervision in accordance with Title XI. §1103 of Title XI states:

The Appraisal Subcommittee must maintain an AMC National Registry of those AMCs that meet the federal definition, panel size threshold and ownership limitations of Title XI **and** that:

- (1) Have a panel of 16 or more appraisers in a single State or 25 or more appraisers in more than one State that are contracted to perform appraisals in connection with covered transactions, and
- (2) Are registered with and subject to supervision of the Board, or
- (3) Operates as subsidiaries of a federally regulated financial institution (Federally regulated AMC).

The Board is required to collect a national registry fee from the applicable appraisal management company of \$25 for each appraiser on the company's panel that performed one or more appraisals in connection with a <u>covered transaction</u> within a 12- month period (S.C. Code Ann. §40-60-360 (B) and (C)). A covered transaction is any consumer credit transaction secured by a consumer's dwelling. It does not have to be <u>a federally related transaction</u>.

The AMC National Registry fee is calculated using the fee calculation period January 1, 2019 – December 31, 2019 and is due before June 30, 2020. The appraisal management company will be updated on the AMC National Registry by July 1, 2020, and upon receipt of full payment of the required fee. This collected fee will cover the term of July 1, 2020, through June 30, 2021.
