Architect Regulations Update - At the last meeting, the Board was informed that Regulation 4984 was withdrawn because the Senate subcommittee had issues with the Minimum Construction Phase Services language in Section 11-11F. Some believe that these additional

requirements of architects would increase construction costs. Senator Massey recommended withdrawing the regulation and asked that the board work on revisions and consult with the senators who had expressed concerns about additional costs. Holly Beeson attended the meeting to discuss the issues presented by Senator Massey. Mrs. Beeson informed the board that they could resubmit the regulations as previously submitted with the Minimum Construction Phase Services language and/or resubmit with that language removed. After a brief discussion, the board will submit the regulations without the revised Minimum Construction Phase Services language.
