2022 NCARB Annual Meeting

The NCARB Annual Meeting will be held in Austin, TX, June 2-4, 2022. The meeting will be held as a hybrid event, where individuals may participate in-person or virtually.

NCARB will fund two board members, one public member, and the member board executive. Administrator Miles will participate virtually.

Motion: To request travel approval for five members, two members to be funded by NCARB and three funded by LLR. Muldrow/Smith/Approved

Revised Motion: Smith and Lawrence to attend as the NCARB funded delegates, Muldrow and Tate to attend funded by LLR and Stevens to attend funded by Clemson University. Muldrow/Sanders/Approved.

SC Regulation 11-12(A)

The Architects regulation passed the House committee (sub and full) last week and passed the Senate subcommittee. After the subcommittee was over, the research director for the LCI committee notified Holly Beeson, LLR Communications and Governmental Affairs, that Senate staff inquired as to why the Board was deleting one of the provisions, Section 11-12 (A)(1).

Stacey Hewson, Advice Counsel, asked the board if they recalled the specific reason why this provision was struck. Member Muldrow commented that it was intentionally struck because it was impossible to regulate and could be construed as conflicting or anti-competitive in that unlicensed persons can perform studies and pre-design.

11-12 Code of Professional Ethics.

An architect or firm shall not engage in dishonest practice, unprofessional conduct, or incompetent practice.

A. Conflict of Interest.

~~*(1) When conditions of compensation are submitted in a proposal for a study, pre-design, or preliminary design service, where future opportunity for additional work on the project is also available to the offerer, such conditions must be consistent and representative of the real cost of services to be performed.*~~
