New Business

NCARB Governance Committee

The board briefly discussed Resolution 2022-E NCARB's Governance Structure which will be voted on at the NCARB Annual Meeting in June. The Resolution would update NCARB's Bylaws to adopt a new governance structure for the Council to be reflective of modern governance best practices and incorporate diversity, equity, and inclusion in the Council's assess to leadership roles and leadership structure.

Continuing Education 11-8.1C(4) disallowance.

Board of Architectural Examiners Board Meeting May 3, 2023

Administrator Miles asked the board for clarification of what is considered disallowance. Per 11.8.1 C(4) The Board may disallow claimed credit for continuing education hours. The registrant shall have forty-five (45) calendar days after notification of disallowance of credit to substantiate the original claim or earn other continuing education credit which fulfills minimum requirements. The board unanimously agreed that continuing education hours (learning units) that are clearly not indicated as health, safety and welfare would not be considered as "disallowed" since the regulation clearly states that; each South Carolina Registered architect shall complete a minimum of twenty-four (24) continuing education hours each biennial licensure period in topics related to health, safety and welfare.

Funding Requests

Clemson University, Emery A. Gunnin Architecture Library Funding Request

Library Funding - The Board considered a request from Clemson Gunnin Architecture Library for \$39,000 from the Board's Education and Research Fund for the purchase of materials for the Architecture Library.

Motion: To approve funding of \$39,000 to Clemson Gunnin Architecture Library. Tate/Lyles/Approved. Member Stevens recused himself from the vote.

Member Tate asked Administrator Miles to research courses in Ethics that applicants could take as a result of disciplinary cases the board may have.
