# **Continuing Education**

In August 2004, a small number of architects were selected randomly by computer for a continuing education compliance audit. We sent memos to each architect requesting submittal of documentation proving the required 12 hours (of which, eight hours should be related to health, safety and welfare) had been obtained during the appropriate time period and the activities met board requirements.

#### **RESULTS**

Most architects promptly submitted acceptable documentation. We extend our thanks to them for their quick response.

Of the group audited, five architects submitted insufficient documentation, or obtained the continuing education after signing the renewal form, or obtained no continuing education at all.

They were issued an Order to Cease and Desist from practicing architecture in S.C. until they comply with the requirements. See Disciplinary Actions for more information.



- · If you have not actually completed the required 12 hours, do not sign the renewal form affirming that you have done so. If you sign the renewal form affirming that you have completed 12 hours, when in fact you have not, you may be sanctioned by the board. (Please refer to Section 40-1-110(1)(a). Please complete the hours and then renew your license, even if you do it after the June 30 deadline and have to renew late.
- · Review the renewal form for correct answers to all questions prior to signing it.
- · If you renew online, you may do it as late as June 30 without paying a late fee, giving yourself extra time for getting continuing education.



# Other Continuing Education Opportunities

In an ongoing effort to provide quality continuing education opportunities, the board will participate as a sponsor of three continuing education activities in S.C. in June along with other state agencies and the S.C. Chapter of the AIA. These daylong seminars will offer participants 6.5 hours of AIA-approved continuing education in health/safety/welfare and will include topics such as Special Inspections, Indoor Air Quality (mold), ADA, LEED and Concrete, and Code Footprint. The seminars will be held in Greenville on June 2, in Charleston on June 9, and in Columbia on June 16. Brochures will be mailed to in-state residents and some architects in bordering locales. Registration is \$50 per person and includes a box lunch.

# Looking for a CE Resource Rich in Health, Safety, and Welfare? Check Out NCARB's Newest Monograph, Building Envelope!

Washington, DC —The National Council of Architectural Registration Boards is pleased to announce the recent publication of Building Envelope, the sixteenth title in its health, safety, and welfare-enriched monograph series. Written by Randall Stout, FAIA, CCIDC, and Michael Garrison, SBSE, IALD, Building Envelope explores the outer walls and roofs that give shape to habitable structures. The monograph also looks at how the evolution of information technology has positively influenced the design and construction of building envelopes—so much so that architects regularly experiment with unusual materials, forms, and functions. Divided into seven chapters, Building Envelope covers such topics as types of envelopes, concepts associated with envelopes, and related construction systems and material selection. The authors, both of whom have significant experience in sustainable practices, also investigate the advanced energy strategies now associated with envelope performance. A final chapter reviews the complexities and challenges of working with computergenerated envelopes. Two case studies and several sidebars augment the main text. Appendices include a detailed listing of resources and a comprehensive bibliography. Building Envelope sells for \$135 (current NCARB Record holders) and \$215 (all other purchasers). Those successfully completing the BE quiz will earn 10 professional development units in health, safety, and welfare. All monograph quizzes may now be taken online through the NCARB web site—an added convenience that eliminates processing time and provides test takers with immediate results. A printable certificate of completion is supplied to all who pass the quiz. NCARB also reports all successfully earned continuing education units to the AIA.

The NCARB monograph series was created in 1993 in order to address the increasing need for continuing education and professional development verification focusing on health, safety, and welfare issues. In addition to *Building Envelope*, the following titles are currently



available: Cracking the Codes, Design Within a Community Context, Energy-ConS.C.ious Architecture, Fire Safety in Buildings, Getting to Smart Growth, Improving Building Performance, Indoor Environment, Low-Slope Roofing I, the award-winning Low-Slope Roofing II, Professional Conduct, Seismic Mitigation, Subsurface Conditions, Sustainable Design, Why Buildings Fail, and Wind Forces.

The Council's next monograph will explore the effects and mitigation of mold in building design. NCARB monographs are a portable and economical professional development resource that investigate subject matter of interest to practicing architects and allied design professionals. All U.S. jurisdictions accept PDP monographs for compliance with state continuing education/professional development requirements. ## National "ROLLING CLOCK" for the ARE



Most of you know that the majority of state boards approved a national "rolling clock" standard for the ARE to be implemented on Jan.1, 2006. After that date, candidates for the ARE must pass the nine-division exam within **five** years or begin losing credits on a rolling basis.

Current S.C. law allows candidates **four** years to pass the ARE. To address this discrepancy and to allow S.C. candidates the same opportunity to pass the ARE as their peers nationwide, the board supports pending legislation, S.C. Senate bill 660, to change the current four-year restriction to a "time period prescribed by the National Council of Architectural Registration Boards (NCARB)." We hope for passage of the bill this session. However, if it does not become law this year, we will correspond directly with each S.C. candidate regarding his/her ARE status.

## **Code Footprint**



Last Fall, we solicited your input on use of a Code Footprint. We received over 150 replies! Thanks to all of you who took time to share your thoughts and concerns with us. The majority of you who responded supported the concept of the Code Footprint, but you expressed concerns about duplication of effort, cost, potential for discrepancies between the Footprint and the design documents, and the extensive list of items included. The same request is being sent to S.C. resident engineers for their feedback.

The Board of Architecture does not intend to initiate legislation that would require the Code Footprint to be submitted along with design documents. The board sought feedback from you as a means of exploring a means of further protection of public health, safety and welfare. Such a Code Footprint would be an invaluable resource to owners, subsequent occupants, fire officials, building officials, and design professionals who might alter the building in the future.

As you know, there are several state agencies that function as permitting authorities in S.C. in addition to the counties and municipalities. They have the authority to require the Code Footprint—or some version of it—with submittals to their office. Please check with the permitting authority when you have a project in S.C. to determine if a Code Footprint is required for plans review and permitting.

# **Disciplinary Actions**

**James C. Stewart Jr.,** Norcross, Ga., who is not currently licensed in S.C., entered into an Consent Agreement with the board for an out of state violation. Sanction imposed was a public reprimand

Thomas Incze, Registered Architect, Charlotte, N.C., entered into a Consent Agreement with the board. Incze admitted that his firm, ABL Architecture and Design, practiced architecture in S.C. without a current license. Sanctions imposed were a public reprimand, \$2,000 fine and immediate firm licensure.

**Harold E. Langbehn**, Jr., Pendleton, S.C. His license remains suspended.

Charles D. Harker, Philadelphia, Pa., entered into a Consent Agreement with the board for falsifying his individual renewal form for 2004-2005 by claiming he had completed 12 hours of continuing education. Sanctions imposed were a public reprimand, \$2,000 fine and documentation showing all continuing education deficiencies have been corrected and satisfied. His license will remain inactive until he has complied with the terms of the Agreement.

John K. Wolff, entered into a Consent Agreement with the board for falsifying his individual renewal form for 2003-2004 by claiming he had completed 12 hours of continuing education. Sanctions imposed were a public reprimand, \$500 fine and documentation showing all continuing education deficiencies have been corrected and satisfied. His license will remain inactive until he has complied with the terms of the Agreement.

**Joseph Perry**, Atlanta, Ga., entered into a Consent Agreement with the board for falsifying his individual renewal form for 2004-2005 by claiming he had completed 12 hours of continuing education. Sanctions imposed were a public reprimand, \$2,000 fine and

documentation showing all continuing education deficiencies have been corrected and satisfied. His license will remain inactive until he has complied with the terms of the Agreement.

Edward L. Eichman, Jr., Charlottesville, Va., entered into a Consent Agreement with the board for falsifying his individual renewal form for 2004-2005 by claiming he had completed 12 hours of continuing education. Sanctions imposed were a public reprimand, \$2,000 fine and documentation showing all continuing education deficiencies have been corrected and satisfied. His license will remain inactive until he has complied with the terms of the Agreement.

**Jack P. Hill**, Charlotte, N.C., entered into a Consent Agreement with the board for falsifying his individual renewal form for 2004-2005 by claiming he had completed 12 hours of continuing education. Sanctions imposed were a public reprimand, \$1500 fine and documentation showing all continuing education deficiencies have been corrected and satisfied. Hill has complied with the terms of the Agreement and his license has been reactivated.

Terry E. Dalton, Charlotte, N.C., entered into a Consent Agreement with the board for falsifying his individual renewal form for 2004-2005 by claiming he had completed 12 hours of continuing education. Sanctions imposed were a public reprimand, \$1000 fine and documentation showing all continuing education deficiencies have been corrected and satisfied. Dalton has complied with the terms of the Agreement and his license has been reactivated.

The board issued three letters of caution for various infractions including violations that occurred in other jurisdictions, registration violations, and holding out as an architect.

## **Individual Renewals**

Your South Carolina individual license will expire on JUNE 30, 2005. We will mail you a renewal notice in early May 2005. The renewal notice will include your user id and individual password as well as instructions for renewing online. YOU MAY EITHER COMPLETE THE FORM AND MAIL IT BACK TO US, OR YOU MAY RENEW ONLINE. The processing fee for online renewals is only \$1.25.

If you do not receive your renewal notice by June 1, please contact us.

Whether you renew online or by completing the form, there are questions you must answer. Please read them carefully and answer them truthfully. You are solely responsible for your answers to these questions. Even if someone else completes the form for you—on paper or

## **Emeritus Architect**

What are the qualifications? You must be at least 65 years old, you must have been licensed as an architect for ten consecutive years in any jurisdiction, and you must be retired from active practice. "Retired from active practice" means "not engaging or offering to engage in the practice of architecture" as defined in Section 40-3-20 of the Architectural Registration Laws.

As an Emeritus Architect, you cannot consult, you cannot serve as expert witness, you cannot advise clients, design, or perform any work that could be defined as architecture.

If you are interested in becoming an Emeritus Architect, you may make that change on the renewal form electronically—you are solely responsible for the information provided.

You are not eligible to renew your license until you have obtained the required 12 hours of continuing education. DO NOT sign and submit the renewal form UNTIL you have actually attended or completed the event. Planning to attend an activity prior to June 30 is unacceptable. Of the 12 hours, at least eight hours must be in technical and professional architectural subjects related to safeguarding life, health, property, and promoting the public welfare. A maximum of four continuing education hours may consist of elective topics related to any other area in the practice of architecture. Of course, all 12 hours may be in health/safety/welfare topics. or you may contact us. If you know someone who qualifies but who is not currently licensed (and therefore will not receive this newsletter), please alert him or her. When you become an Emeritus architect, you will retain the same South Carolina license number, you will receive all publications and notices, and you may use the title "Emeritus Architect."

There is a place on the renewal form to check if you want to change from active status to Emeritus status. The annual fee for in-state Emeritus architects is \$30; for out-of-state Emeritus architects, the fee is \$40. You are NOT required to obtain continuing education to change to Emeritus status or to retain your Emeritus status.

We will send you a letter acknowledging your status, but we will not send you a "license."

## **Board Policy Regarding Specialty Systems**

The South Carolina Board of Architectural Examiners has adopted the following policy regarding 'specialty system' drawings and/or specifications prepared by suppliers, vendors, subcontractors, or others when bound as a part of bid or contract documents.

Examples of 'specialty systems' include, but are not limited to, the following:

- food service
- acoustical systems
- auditorium or stadium seating
- science equipment
- stage performance equipment
- wiring schematics
- control diagrams
- fire/smoke seals

#### **Policy**

Architects shall not seal '<u>specialty system</u>' drawings and/or specifications which are not prepared under their direct supervision and review (Regulation 11-12.D.1). To do so constitutes a violation of the South Carolina Board of

Architectural Examiners Regulation 11-11 (B), Seals.

Drawings and/or specifications for 'specialty systems' may be included as a part of the bid or contract documents provided that the following conditions are adhered to:

- Documents shall bear originators' firm name, address, date, and title block.
- Technical '<u>specialty system</u>' designs which require the seal of a South Carolina registered engineer shall bear such seals.
- <u>'Specialty</u> Systems' documents shall be listed in the project Drawing Index and/or Table of Contents under a heading or subscript clearly indicating that they were not prepared under the supervision of the 'design professional in responsible charge'.
- Information contained in the 'specialty system' documents shall have been reviewed by the 'design professional in responsible charge' who shall verify that the specialty system is appropriate for the use intended and meets all applicable code requirements.
