## **Meeting Called to Order:**

Pamela Shealy, Chair, called the meeting of the South Carolina Athletic Commission to order at 11:30 a.m. Ms. Shealy announced that public notice of this meeting was properly posted at the S.C. # Approval of Agenda

Mr. Shoemake made the motion to approve the agenda. Mr. McCullough seconded the motion which carried unanimously.

# In the matter of Andrew Stokes: Motion to vacate fines for late Gate Fee Verification Forms and permit application for April 30th event.

Ms. Shealy called the hearing to order to consider the request made by Andrew Stokes to vacate the assessment of a \$2000.00 fine for failure to pay required gate fees within the time required for an events on October 24, 2015 and November 7, 2015. Additionally, he requested an approval for his event on April 30, 2016. Mr. Stokes waived his right to a 30 day notice of a hearing.

Discussion and testimony ensued.

Mr. Shoemake made the motion to waive any fines for Mr. Stokes for the two events missing gate fees, to grant the event permit for the upcoming April 30, 2016 event and that Mr. Stokes have 30 days from the receipt of the board order to sit with staff and reconstruct ticket sales to pay the required gate fees. Mr. McCullough seconded the motion which carried unanimously.

# Age-Waiver Hearing - MMA - Adrian Henderson

Pamela Shealy called the application hearing to order regarding whether Mr. Adrian Henderson should be granted an age restriction waiver to participate in mixed martial arts events for the remainder of the 2016 licensure period. Discussion ensued.

# **Boxing Officials Recommendation - Nikki Messer**

Nikki Messer presented to the Commission regarding the use of MMA officials in boxing events. She stated that the ABC would recognize the rulings of officials with MMA experience as long as they were qualified by the State. Ms. Messer recommended MMA officials Bradley Wade and Blake Grice to transition to professional boxing. Discussion ensued.

### **Investigative Review Committee (IRC)**

Ms. Shealy presented to the Commission the names considered at the last board meeting regarding a professional member for the IRC. Mr. Bradley Wade, Mr. Abe Stem and Mr. Corey Goodwin were recommended to the Commission. No other recommendations were made. Mr. Atkinson also spoke to the Commission regarding the role of the professional member and the appearance of an unbiased group. The Commission decided to postpone this discussion to the next quarterly scheduled Commission meeting.
