# **Investigative Review Committee**

Ms. Shealy expressed a need for a new member and alternate member for the Investigative Review Committee (IRC). Discussion ensued. Those in attendance and the public were asked to volunteer or suggest possible members in the community for the IRC. Mr. Corey Goodwin volunteered. Mr. McCullough recommended Bradley Wade and Abe Stem. This discussion was tabled until the next quarterly board meeting taking place May 3, 2016.

## In the Matter of Justin Mitchell

The hearing for Justin Mitchell was called to order. Mr. Mitchell requested a special hearing to contest the legality of a \$1000.00 fine for failure to pay the required gate fees within the time required for an event on August 28, 2015. Additionally he was requesting approval of his application for licensure as a promoter and his application for an event permit for an event scheduled May 7, 2016. Mr. Mitchell waived his thirty (30) day notice of a hearing. Mr. Mitchell

was not represented by legal counsel. The State of South Carolina was represented by Kyle Tennis of Office of Disciplinary Counsel.

Discussion and testimony ensued.
