- **f.** <u>Staff Updates</u> 1 new staff person will be hired to replace Larry Hall, who retired recently.

Michelle Phillips, from the Office of Operational Management, has been working to update all Athletic Commission forms and prepare for making applications available online.

Medical/Death bond form has been drafted with the assistance of Wick Stuart, Office of Advice Counsel.

### **NEW BUSINESS:**

- **a.** Casey Oxendine, CEO of HipShow, parent company of <u>Arena Combat</u>, gave a presentation and showed a brief video, regarding Arena Combat. Arena Combat is America's first two on two fighting event. Mr. Oxendine took questions from the Commission regarding the procedures and safety precautions that are being followed in other states.
- **b.** Brad Benik, fitness professional and licensed massage therapist, gave a presentation and showed a short video entitled "<u>To Train a Fighter</u>".
- **c.** Ms. Shealy and Mr. Eubanks gave an update on their attendance at the recent <u>2014 ABC Convention</u> in Clearwater, Florida. The 2015 ABC Conference will be held in San Diego, CA, July 25 29, 2015.
- **d.** The <u>Community Task Force</u> met in June and July, and will meet again today at 2:00 p.m. A report was distributed for review. The goal is to have a finished packet ready to present to the Senate by January, 2015.
