1. Meeting Called to Order

A. Public Notice

2. Approval of Agenda

Mr. Holiday called for a motion to approve the agenda.

5. Approval of Minutes from the August 10, 2022 meeting

The Commission members reviewed the minutes. Mr. Holiday called for a motion.

MOTION: Mr. Hope made a motion, seconded by Mr. Dixon, to approve the August 10, 2022 minutes without corrections. The motion carried unanimously.

7. Administrator's Remarks - Amy Holleman

A. Financial Report

Ms. Holleman informed the Commission that the cash balance on October 31, 2022 was \$569,850.74 and the Recovery Fund balance was \$126,051.10.

8. Reports

A. Investigative Review Committee (IRC) - James Kemfort

Mr. Kemfort asked that the Commission review and approve the October 18, 2022 Investigative Review Committee Report recommending a dismissal of cases 2022-15, 2022-17, and 2022-18; to dismiss with a Cease & Desist to case 2022.16, and file a formal complaint for case 2022-19.

Mr. Holiday called for a motion in this matter.

MOTION: Mr. Dixon made a motion, seconded by Ms. Davey, to approve the Investigative Review Committee's recommendation. The motion carried unanimously.

B. Office of Investigation and Enforcement (OIE) – James Kemfort

Mr. Kemfort presented the OIE report as information only. There were 20 complaints received between January 1, 2022 and October 18, 2022. There are two active investigations.

C. Office of Disciplinary Counsel Report (ODC) – Alexis Bell

Ms. Bell presented the November 7, 2022 ODC Report as information only: two open cases, two pending hearings & agreements, and two closed since January 1, 2022.

9. A. Consent Agreement

1. Case No.: 2021-17

Ms. Alexis Bell, Disciplinary Counsel, presented the Consent Agreement.

After ensuring if the Board had any questions or comments, Mr. Holiday called for a disposition in this matter.

MOTION: Mr. Dixon made a motion, seconded by Ms. Davey which carried unanimously that the Commission accepts the Consent Agreement.

A. Online/Distance Learning for Pre-licensing Education

1. Missouri Auction School

The representatives of Missouri Auction School were unable to attend and asked to reschedule the hearing. The Commission granted the request.

11. Regulatory Review

Mr. Horner stated that, according to statute, every five years Boards/Commissions are required to conduct a Regulatory Review. The review should identify any regulation that unnecessarily burdens the pursuit of professional and occupational practice in the state or that no longer serves the purpose of promoting the health, safety and economic well-being of the public. It should identify any opportunities to amend the current regulations to better promote the health, safety, and economic well-being of the public and identify those that do not require either repeal or amendment because these will continue to promote the health, safety, and economic well-being of the public in the least restrictive manner.

The Commission discussed the matter and after ensuring there were no further questions/statements Mr. Holiday called for a motion.

MOTION:

Mr. Dixon made a motion, seconded by Mr. Hope, which carried unanimously that the Commission finds that the current regulations sufficiently protects the public and are not burdensome to the licensee. The Commission does not plan to repeal and/or revised any regulations at this time.
