A. Public Notice

2. Approval of Agenda

A. Financial Report

B. Office of Investigation and Enforcement (OIE) – James Kemfort

Mr. Kemfort presented the OIE report as information only. There were 2 complaints received between January 1, 2023 and May 15, 2023. There are no active investigations.

C. Office of Disciplinary Counsel Report (ODC) – James Kemfort

Mr. Kemfort presented the March 15, 2023 ODC Report as information only: one open case, no pending hearings & agreements, and two closed since January 1, 2023.
