# 2021-2022 APPRENTICE AUCTIONEER RENEWAL APPLICATION

### **Renewal Instructions/Requirements:**

- Renewal fee of \$200 in the form of a check or money order only (no cash) made payable to Auctioneers' Commission. (All fees are non-refundable. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds.)
- Your renewal must be postmarked on or before June 30, 2021, to avoid late fees.
- Renewal / Late Fees:

Postmarked 6/30/2021 or before: \$200

Postmarked 7/1/2021 - 7/31/2021: Late Fee \$25 + Renewal Fee \$200 = **\$225** 

Postmarked 8/1/2021 - 9/30/2021: Late Fee \$100 + Renewal Fee \$200 = **\$300** 

After September 30, 2021, your license is lapsed. A new application will need to be submitted and an exam taken for reinstatement.
