# 2023-2025 LICENSE RENEWAL FOR AUCTION FIRM

#### **Renewal Instructions/Requirements:**

- Biennial renewal fee of \$300 in the form of a check or money order only (no cash) made payable to Auctioneers' Commission. (All fees are non-refundable. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds.)
- Your renewal must be postmarked on or before June 30, 2023, to avoid late fees.
- Biennial Renewal / Late Fees:

Renewed/postmarked on or before 6/30/2023: **\$300** Renewed/postmarked 7/1/2023 - 7/31/2023: Late Fee \$25 + Renewal Fee \$300 = **\$325** Renewed/postmarked 8/1/2023 - 9/30/2023: Late Fee \$100 + Renewal Fee \$300 = **\$400** 

- After September 30, 2023, your license is lapsed and must be reinstated.
- If the original applicant (Qualifying Party) for the firm license is no longer with the company, a revised firm application with the updated information along with this renewal form must be submitted. If the new qualifying party is not a licensed auctioneer, the new qualifying party must take the firm exam.
