

RECIPROCAL STATES

SC license requires 8 hours of continuing education during a 2-year period (renewals are in odd years, so 7/1/2023 – 6/30/2025 would be a renewal period). A reciprocal license is granted for the initial licensing in this state. If your state requires less than 8 hours during this 2-year period, you must complete the additional hours to satisfy SC license renewal. All licensees must have 8 hours of CE during a renewal period before renewing and all hours must be reported to your CE Broker account BEFORE renewal of the license.
