2025-2027 MODULAR BUILDING MANUFACTURER'S REPRESENTATIVE RENEWAL APPLICATION

Renewal Instructions/Requirements:

- Biennial renewal fee of \$200 in the form of a check or money order only (no cash) made payable to SC Building Codes Council. (All fees are non-refundable. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds.)
- Current surety bond in the amount of \$10,000, with an expiration date of June 30, 2027. A bond continuation form is acceptable, or if a new bond is being issued it must be on the Council's <u>form</u> and signed by the principal. An electronic signature is acceptable if required, but Docusign is not. The surety bond may be submitted with the renewal application, or uploaded through the Document Submission portal: https://eservice.llr.sc.gov/DocumentSubmission/.
- Your renewal form and other applicable documentation must be postmarked on or before **June 30, 2025.** If not postmarked by June 30, 2025, the license will be LAPSED, and applicants must reapply.
- The Modular Building Manufacturer's license must be renewed before the Modular Building Manufacturer's Representative renewal application will be considered complete.
- Renewal form and attachments may be returned without processing if not complete.
