Self-Pace Online Courses

Due to the ongoing COVID-19 pandemic, the Building Codes Council will temporarily allow self-pace online Continuing Education (CE) courses. These courses will serve as a means of earning continuing education hours through the June 30, 2021, registration cycle, along with in-person or live web courses.

In order to qualify as continuing education credit, a self-pace online course must be offered by ICC or a Council approved CE provider and be appropriate for your registration type. Any or all of the required twenty-four (24) CE hours in a registration cycle may be earned through qualifying self-pace online courses. Likewise, the Council will accept reimbursement requests for the courses up to the required 24 CE hours.

The Council still recognizes the importance of live in-person training, but understands that the COVID-19 pandemic has created travel and financial barriers in obtaining CE hours during this registration cycle. The Council will address the continued use of self-pace online courses for the 2021-2023 registration cycle at a later meeting date.
