The documents reviewed included the Moderate/Enteral Sedation Application, Deep Sedation/General Anesthesia Application, Change of Practice Form for mobile providers, the Inspection Checklist Form to be used by the dental office inspectors, and sample permit forms. Each document was reviewed and examined with a few editorial edits made.

After discussion of these documents, a motion was made to approve them and to forward them to the South Carolina Dental Board members for review and approval at their next board meeting on October 13, 2017. The Sedation application forms will be placed on the Dental Board website after the Dental Board approves them and an e-blast will be sent to dentists informing them to go to the dental board website for instructions and submission of the forms.
