#### 9. Old Business

# a. RPP Questionnaire-Rebecca Gillespie, PharmD

Several Board members met to review and suggest changes to the questionnaire that would meet the needs of the Board and the licensees. The Board voted to accept the changes of the working committee. No seconded was needed since it was coming from the committee.

b. Final Review of Emergency COVID orders

The emergency COVID orders expire July 1, 2021 and will be removed from the website.

#### 10. New Business

# a. FDA Q&A-Gabey Cousel, FDA

The FDA appeared before the Board to answer questions regarding the MOU. The MOU provides a mechanism by which states can report information on state-licensed pharmacies within their state that are distributing more than 50% of their compounded drug products outside of the state. There is further discussion on the transcript.

#### b. FDA MOU Data Sharing-Eileen Lewalski, NABP

Ms. Lewalski provided an overview of the MOU. The Board that signs the MOU will be required to report facilities compounding more than 50% of drug products outside the state. Many Boards will have to make legislative changes to meet the parameters of the MOU. NABP has been given a grant to help with the process of gathering information from the state boards. There is further discussion on the transcript.

# c. RPP Overview-Robyn Madden and Tia Cooper

Ms. Madden and Ms. Cooper gave an overview of the RPP process and stated that there will be changes to the process.

# d. Legislative Updates-Katie Phillips

Ms. Phillips gave the Board an update on the legislative session. In S.427/Act 48, it allows renal drug manufacturers to deliver to the patient. It was amended with an exemption for pharmacists and pharmacy technicians to not obtain CE in person. The Act became effective May 17, 2021.

Other legislative updates:

In S.571/Act 22, prescribers are required to offer Naloxone or similar medication to their patients if they meet certain conditions. The Act became effective July 25, 2021.

H.3179/Act 23, amends the controlled substance statute to exempt surgically implanted drug delivery systems from the 31-day supply for schedule two limits. The Act became effective April 25, 2021.

Bill S295 was present at information. It will limit the criminal convictions that a board or commission can consider when looking at an application for licensure.

S690, allows an originating pharmacy permitted by the state to outsource prescription drug orders to a central fill pharmacy.

Further discussion about legislation is on the transcript.
