Board Meeting Notes

The Board discussed items at its recent meetings based on questions from licensees and permit holders.

- Due to ambiguity in the statute, for the time being, the Board recognizes that hormonal contraceptives can be prescribed through a standing order or come directly from a pharmacist following the protocol provided by the SC Pharmacy Access Act. SC Senate Bill 477 seeks to clarify this language.
- Certified pharmacy technicians
 may restock cabinets loaded

with unit dose medications within a permitted institutional facility, provided that the pharmacy technician is appropriately supervised in accordance with the SC Pharmacy Practice Act.

- Health-system-owned, nondispensing drug outlets that store and/or administer controlled substances should not be rostered under the Health System Non-Dispensing Drug Outlet permit but should be permitted separately.
- Virtual inspections are not currently permitted by the

Board for any reason. However, the Board is exploring available options and the feasibility of instituting virtual inspections in limited, time-specific instances.

Final virtual verification prior to dispensing must be conducted in person. While virtual technologies may be employed through the workflow process, the final check must be done by a licensed pharmacist physically, in person, looking at the final dosage form product. Virtual verification is not permitted in South Carolina.

FDA Discretion Periods End for Compounding Tirzepatide and Semaglutide

Food and Drug Administration (FDA) has issued updated timelines for state-licensed pharmacies and outsourcing facilities compounding tirzepatide and semaglutide.

State-Licensed Pharmacies	Tirzepatide	Semaglutide
State-licensed pharmacies or physicians compounding, dispensing, or distributing under Section 503A of the Federal Food, Drug, and Cosmetic Act (FD&C Act)	Enforcement discretion for compounding tirzepatide has ended.	Enforcement discretion for compounding semaglutide has ended.

Outsourcing Facilities	Tirzepatide	Semaglutide
Outsourcing facilities compounding, distributing, or dispensing under Section 503B of the FD&C Act	Enforcement discretion for compounding tirzepatide has ended.	Enforcement discretion remains in place until May 22, 2025.

FDA will take action against facilities that violate any other statutory or regulatory requirements, such as dispensing products that are found to be unsafe. Information about the policies for compounders of tirzepatide and semaglutide injection products can be found on FDA's website.
