#### **RENEWAL INSTRUCTIONS/REQUIREMENTS**

- Perpetual Care Cemetery license with 10 acres or less renewed on or before January 31, 2020, fee is \$400.
- Perpetual Care Cemetery license with more than 10 acres renewed on or before January 31, 2020, fee is \$850.
- A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds. All fees are non-refundable.
- Failure to renew by December 31, 2019, renders the license invalid. The license may be reinstated by January 31, 2020. After January 31, 2020, you must submit the initial application packet and fee to reinstate the license. Visit the Board's webpage at <u>www.llr.sc.gov/cem</u> for additional information.
