Dr. Coon called the meeting to order and noted that a quorum was present to conduct business.

Dr. Coon gave the Hearing Opening Statement. The meeting proceeded with Case# 2005-2.

## Case # 2005-2

Motion: Paula Margargle, LLR Legal Counsel made a motion prior to the beginning of the case that based on the nature of this case that the Hearing be closed to the public. The motion was seconded. The motion carried.

Dr. Coon asked everyone not involved with the case to leave the room due to the sensitivity of the case.

Paula Margargle, LLR Legal Counsel summarized the Order of Case# 2005-2. Don Coggins, Legal Counsel for the Respondent vave opening statement and agreed that a Memorandum of Agreement had been signed and gave additional facts that be believed would be revelent to the Board's decision on the Respondents license and on disciplinary action.

Paula Margargle, LLR Legal Counsel summarized the Order of Case# 2005-39 and 2005-40. C. Craig Young, Legal Counsel for the Respondent gave opening statement. The Respondent answered questions presented by the Board.

Motion: Dr. Lacey made a motion that the Board impose an additional eight hours of continuing education. Four hours of Encoding; four hours of documentation that is to run concurrent with the continuing education requirements that ends on September 30<sup>th</sup>, both coursed must be completed by that date; and levied a \$500 fine, plus court costs. Motion: Dr. Ehlich moved to proceed with a Letter of Caution in Case#2005-11. The motion received a second. The motion carried unanimously.

## **Application Hearing**

**Jeremy B. Wills, D.C.** an applicant for licensure appeared before the Board without legal representation or witness. Dr. Wills answered "yes" to question number five on the application, "Have you ever been arrested, charged or convicted, including nolo contender plea or guilty plea in any State or Federal Court other than minor traffic violation, whether or not sentence was imposed or suspended?"

Motion: A motion was made to convene to Executive Session to deliberate on the matter of Dr. Wills. The motion received a second. The motion carried.

Motion: Dr. Coon moved that the Board reconvene to public session. The motion received a second. The motion carried.

Motion: Mr. Mercer moved to grant Dr. Wills a Chiropractic license without conditions. The motion received a second. The motion carried unanimously.

**Anthony W. Carpenter, D.C.** an applicant for licensure submitted a letter of explanation to the Board office that served as his testimony. Dr. Carpenter answered "yes" to question number five on the application, "Have you ever been arrested, charged or convicted in any State or Federal Court, whether or not sentence was imposed or suspended?"

Motion: Dr. Coon made a motion to accept Dr. Carpenter's Affidavit and move into Executive Session. The motion received a second. The motion carried.

Motion: Dr. Coon made a motion to reconvene to Public Session. The motion received a second. The motion carried.

Motion: Dr. Garcia made a motion to approve Dr. Carpenter's application for license. The motion was seconded. The motion carried unanimously.

**Jack V. Hormell, Jr., D.C.** an applicant who license to practice Chiropractic expired on June 30, 2004, appeared before the Board without legal representation or witness. Under Section 25-5(A) (2) (c) of the South Carolina Code of Regulations, an applicant whose license has been expired for more than three years must meet the requirement for a new license. Dr. Hormell needs to provide evidence that he has passed Parts I and II of the National Board of Chiropractic Examiners and pass a practical examination approved by the Board. Transcripts received by the NBCE certify that he did not successfully complete examinations Part I, II and IV.

Motion: A motion was made to convene to Executive Session to deliberate on the matter of Dr. Hormell. The motion received a second. The motion carried.

Motion: Dr. Coon made a motion to reconvene to Public Session. The motion was seconded. The motion carried.

Motion: Mr. Mercer made a motion to waive the last year of Dr. Hormell's lapse so that he is moved back into the category where he can renew upon payment of fees and penalties based on extenuating circumstances and submit satisfactory evidence of continuing education for that period. The motion was seconded. The motion carried unanimously.

**LEGISLATIVE UPDATE:** Ms. Stephenson advised the Board that as of May 2, 2008 information was received that the Regulation the Board submitted to application renewal and continuing education was referred to the Medical Affairs Committee and is schedule to time out on March 31, 2009.

**RECORD-KEEPING & DOCUMENTATION:** Dr. Farrel Grossman, President of the South Carolina Chiropractic Association discussed with the Board the appropriate record-keeping and documentation format. Dr. Grossman recommended that the Medicare standard format be used since it offers a good basis that would not infringe on anyone philosophy in Chiropractic, yet offer a communication device that will work so everyone will understand their records and documentation. Individuals can substantiate not only their diagnosis but their treatment for that patient through that type of documentation.

**ADVERTISING & SOLICITATION:** Dr. Coon addresses the letter of recommendation from Dr. H.W. Hulteen regarding Advertising & Solicitation. Discussion was tabled for November Board meeting.

**ACBA MEETING:** Ms. Stephenson briefed the Board on the ACBA Meeting that was held in Atlanta, Georgia.

**NBCE & FCLB SPRING MEETING:** Dr. Coon and Dr. Banks briefed the Board on the NBCE & FCLB Meeting that was held in Atlanta, Georgia.
