Dr. Coon called the meeting to order and noted that a quorum was present to conduct business.

IRC REPORT: The Board voted to accept the recommendation of the IRC and approve the October 29, 2009 IRC Report:

The Board voted to proceed with a Formal Complaint for the following complaints: Complaint #5-

APPLICATION HEARINGS:

Jerry D. Odom, DC an applicant for licensure appeared before the Board to discuss his "yes" answer to question number five on the application, "Have you ever been arrested, charged or convicted, including nolo contender plea or guilty plea in any State or Federal Court other than minor traffic violation, whether or not sentence was imposed or suspended?"

After his testimony and review of the information he presented, the Board unanimously voted to approve Dr. Odom's application and to grant him a Chiropractic license.

Lincoln J. Cole, DC an applicant for licensure appeared before the Board to discuss his "yes" answer to question number five on the application, "Have you ever been arrested, charged or convicted, including nolo contender plea or guilty plea in any State or Federal Court other than minor traffic violation, whether or not sentence was imposed or suspended?"

After his testimony and review of the information he presented, the Board unanimously voted to approve Dr. Cole's application and to grant him a Chiropractic license.

Joseph Kuna, DC an applicant for licensure appeared before the Board to discuss his "yes" answer to question number five on the application, "Have you ever been arrested, charged or convicted, including nolo contender plea or guilty plea in any State or Federal Court other than minor traffic violation, whether or not sentence was imposed or suspended?"

After his testimony and review of the information he presented, the Board unanimously voted to approve Dr. Kuna's application and to grant him a Chiropractic license.

Jarrod D. Haselden, DC an applicant for licensure appeared before the Board to discuss his "yes" answer to question number five on the application, "Have you ever been arrested, charged or convicted, including nolo contender plea or guilty plea in any State or Federal Court other than minor traffic violation, whether or not sentence was imposed or suspended?"

After his testimony and review of the information he presented, the Board unanimously voted to approve Dr. Haselden's application and to grant him a Chiropractic license if he has an evaluation and signs a Contract for 5 years with the Recovering Professionals Program (RPP) or RPP says no Contract is needed. DISCUSSION TOPICS:

FCLB/NCBE District IV MEETING-Dr. Coon and Dr. Banks briefed the Board on their attendance at the Oct. 2009 Meeting. They noted the importance of participation and networking with other state's Board members because of the similar issues faced. Other topics discussed included decompression, issues faced by offices with multiple disciplines, DCs providing DOT physicals, etc.

AGREEMENT TO RELINQUISH LICENSE:

2008-55- Ms. Lewis, LLR Attorney presented an Agreement to Relinquish License signed by Dr. Robert E. Powers voluntarily relinquishing his license to practice in SC in lieu of facing a disciplinary hearing.

CONSENT AGREEMENT:

2006-21 -Ms. Andino, LLR Attorney presented a Consent Agreement signed by Dr. Michael A. Addison acknowledging failure to document records, failure to maintain records properly, submitting false claims for services not rendered and failure to provide medical records to patient in a timely manner. The Board voted to accept the signed Consent Agreement to allow respondent's license to be placed on probation for 3 years, obtain 10 hours of c.e. in record keeping and professional ethics and pay a monetary fine.

CONSENT AGREEMENT:

2008-50 -Ms. Andino, LLR Attorney presented a Consent Agreement signed by Dr. Larry E. Simon acknowledging that he attempted to administer care to a patient while impaired. The Board voted to accept the signed Consent Agreement for a Public Reprimand. Dr. Simon is required to be an active participant in the Recovering Professionals Program (RPP) for a minimum of 5 years during which he is subject to random drug screenings, etc.

FINAL ORDER HEARING:

2005-1

Ms.Hawkins, LLR Attorney summarized Case # 2005-1 and presented the Hearing Examiner's Report and Recommendations. The Board voted to accept the Hearing Examiner's Report and Recommendations for a Private Reprimand. The licensee is to complete 6 hours of Board approved coursework related to child abuse. See attached Order

FINAL ORDER HEARING:

2005-4

Ms.Andino, LLR Attorney summarized Case # 2005-4 and presented a Memorandum of Agreement signed by the respondent Dr. David Richard Gooldy admitting to filing multiple false insurance claims, failure to maintain and document records properly. An Order was issued by the Board for a Public Reprimand, 3 years probation, monetary fines/court costs, successful completion of the NBCE Ethics Course and 12 hours of Board approved coursework in documentation. See attached Order.

FINAL ORDER HEARING: #2007-12 & 2008-40

Ms. Andino, LLR Attorney summarized Cases # 2007-12 & 2008-40 and presented a Memorandum of Agreement signed by the respondent Dr. Stephen A. Conicello admitting that he gave unsubstantiated and misleading statements in advertisements and statements that he was a "Master Level Upper Cervical Chiropractor." An Order was issued by the Board for a Public Reprimand, 3 years probation, monetary fines and successful completion of the SC Board Rules & Regulations Examination.
