**GENERAL and MECHANICAL CONTRACTORS**

- 1. **Initial License Fee**.....\$350  
*(General Contractors expire 10/31/every even-numbered year; Mechanical Contractors expire 10/31/every odd-numbered year)*
- 2. **Biennial License Renewal Fee** (until 10/31) .....\$135  
**Late Payment Penalties** (add penalty to \$135 biennial renewal fee)
  - November 1 - November 30 .....\$100
  - December 1 - December 31 .....\$150
  - January 1 - January 31 .....\$200
- 3. **Reinstatement Fee** (after January 31; submit [Initial Application, Doc #165](#)).....\$350
- 4. **Annual Inactive Certificate Status Fee** (per year; up to 4 years).....\$10
- 5. **Annual Inactive License Status Fee** (per year).....\$110
- 6. **Biennial Certificate Fee**.....\$10
- 7. **Replacement of Lost/Destroyed Certificate**.....\$10
- 8. **Replacement of Lost/Destroyed License** .....\$5

- 1. **Initial License Fees** (includes one primary qualifier)
  - Alarm System Business License.....\$200      Additional Qualifying Party .....\$10
  - Branch Office (each office).....\$50
- 2. **Biennial Renewal Fee** (until July 31; includes one primary qualifier)
  - Alarm System Business License (each office).....\$85      Additional Qualifying Party .....\$10
  - Branch Office (each office).....\$50
  - Late Renewal Penalties** (add penalty to above biennial renewal fee)
    - August 1 - August 31 .....\$100      October 1 - October 30 .....\$175
    - September 1 - September 31 .....\$150
- 4. **Reinstatement Fee** (after October 31; submit [Initial Application, Doc #130](#)) .....\$200
- 5. **Replacement of Lost/Destroyed Certificate** .....\$10
- 6. **Replacement of Lost/Destroyed License**.....\$10

**FIRE SPRINKLER PROTECTION SYSTEMS CONTRACTORS**

- 1. **Initial License Fee** (includes one primary qualifier)
  - Fire Sprinkler Contractor License.....\$200      Each Additional Qualifying Party .....\$50
  - Branch Office (each office) .....\$100      *(Main or Branch Office)*
- 2. **Renewal Fees** (until July 31; includes one primary qualifier)
  - Fire Sprinkler Business.....\$85      Each Additional Qualifying Party .....\$50
  - Branch Office (each office) .....\$100      *(Main or Branch Office)*
  - Late Renewal Penalties** (add penalty to above renewal fee)
    - August 1 - August 31 .....\$100      October 1 - October 31 .....\$200
    - September 1 - September 30 .....\$150      November 1 - November 30 .....\$250
- 3. **Reinstatement Fee** (after November 30, submit [Initial Application, Doc #145](#)).....\$200
- 4. **Transfer Qualification Certificate to another licensee** .....\$10
- 5. **Replacement of Lost/Destroyed Certificate** .....\$10
