### **MINUTES**

### South Carolina Contractor's Licensing Board Board Meeting July 17, 2025, 10:00 a.m.

July 17, 2025

### WELCOME AND CALL TO ORDER:

Legrand Richardson, Board Chairman, called the regularly scheduled meeting of the South Carolina Contractor's Licensing Board to order at 10:00 a.m.

Mr. Richardson announced that public notice of this meeting was properly posted at the Synergy Business Park, Kingstree Building, and on the Agency's website, and provided to all requesting persons, organizations, and news media per Section 30-4-80 of the South Carolina Freedom of Information Act.

### APPROVAL OF AGENDA

### **Motion**:

Mr. Appleton made a motion to approve the July 17, 2025 agenda. Mr. Lehman seconded the motion which carried unanimously.

### INTRODUCTION OF BOARD MEMBERS

Mr. Richardson introduced himself and the following Board members: Kimberly Lineberger, Daniel Lehman, Scott Appleton, Terry Marcum, John Williams, Courtney Walsh, and J. Keith Lindler.

### APPROVAL OF EXCUSED ABSENCES

### **Motion**:

Ms. Lineberger made a motion to approve the excused absence for Mr. Edward Gibbs due to scheduling conflicts. Mr. Appleton seconded the motion, which carried unanimously.

### APPROVAL OF MEETING MINUTES

#### Motion:

Mr. Appleton made a motion to approve the April 17, 2025 Board Meeting minutes. Ms. Lineberger seconded the motion, which carried unanimously.

### BOARD CHAIRMAN REMARKS - Legrand Richardson Jr.

Mr. Richardson welcomed everyone to the Board meeting and informed everyone that this may be a long meeting due to the number of Agenda items.

#### STAFF REPORTS

### **Board Executive's Report – Meronica Fulton**

Ms. Fulton welcomed everyone to the Board meeting and directed the Board members to the PSI report, cash report, and licensure statistics provided in the meeting materials. The licensure examination report and current balance of school donations were provided to Board members in their meeting materials packet. There are currently 11,193 licensed general contractors and 8,012 licensed mechanical contractors. There are currently 532 burglar alarm company licenses, 24 burglar alarm branch licenses, 400 fire alarm company licenses, 225 fire sprinkler company licenses, and 28 fire sprinkler branch company licenses.

Ms. Fulton informed the Board that the mechanical contractor license renewals will open in August of 2025. To assist staff and licensees with expediting this process, Board staff has begun obtaining and processing financial documents submitted by the mechanical contractors.

Ms. Fulton notified everyone that the next Board meeting is scheduled for October 16, 2025.

### Office of Investigation and Enforcement (OIE) Report – Maurice Smith

Mr. Smith reported that OIE received 367 total complaints related to contractors since January 1, 2025. There are currently 36 active investigations, 253 closed cases, and 78 cases pending other actions.

Mr. Smith reported that since January 1, 2025, OIE received 17 total complaints for burglar alarm and fire alarm. There is currently 1 active investigation, 16 closed cases, and 0 cases pending other actions.

### Investigative Review Conference Report (IRC) – Maurice Smith

Mr. Smith presented IRC reports from the IRC meeting on June 26, 2025, for the Board's approval. The IRC recommended 30 cases for dismissal, 15 cases for formal complaints, 2 cases for formal complaints with citations, and 3 cases for a letter of caution for contractors.

For burglar, fire alarm, the IRC had 0 cases to review.

### Motion:

Mr. Appleton made a motion to approve the June 26, 2025 IRC report, as presented. Ms. Lineberger seconded the motion, which carried unanimously.

### Office of Disciplinary Counsel (ODC) – Chris Elliott

Mr. Elliott presented the ODC report for informational purposes only. There are currently 179 open cases in ODC. Of those cases, 79 cases are pending hearings and agreements. Since the last report on April 04, 2025, 14 cases have been closed, and 29 cases have been closed since January 1, 2025.

### **DISCIPLINARY HEARINGS – Final Order Hearings**

Case No(s): 2024-952 and 2024-1057

Chris Elliott, Office of Disciplinary Counsel, represented the State. The Respondent was not present at the hearing. In accordance with Board confidentiality statutes, the hearing was closed.

Mr. Lehman recused himself from this hearing due to serving as the hearing officer in this case. The recusal form was signed, and a copy was provided to the court reporter.

Mr. Elliott stated that the Qualifier in this matter has accepted the Hearing Officer's Recommendation, as written, and did not wish to make an appearance before the Board to challenge the Recommendation. The Waiver of Final Order Hearing was signed by the Qualifier, and a copy was introduced into evidence and provided to the Board members.

Mr. Appleton made a motion to accept the Hearing Officer's Recommendation, as written. Ms. Lineberger seconded the motion, which carried unanimously.

### Case No: 2023-191

Chris Elliott, Office of Disciplinary Counsel, represented the State. The Respondent was not present at the hearing. In accordance with Board confidentiality statutes, the hearing was closed.

Mr. Lehman recused himself from this hearing due to serving as the hearing officer in this case. The recusal form was signed, and a copy was provided to the court reporter.

### **Motion:**

Mr. Lindler made a motion to accept the Hearing Officer's Recommendation, as written. Mr. Williams seconded the motion, which carried unanimously.

Mr. Lehman rejoined the meeting.

### Case No(s): 2018-348, 2018-383, and 2021-393

Katherine Barroll, Office of Disciplinary Counsel, represented the State. The Respondent was present at the hearing and was represented by Charles Krawczyk, Esq. All persons testifying were sworn in by the court reporter. In accordance with Board confidentiality statutes, the hearing was closed.

Mr. Appleton recused himself from this hearing due to serving as the hearing officer in this case. The recusal form was signed, and a copy was provided to the court reporter.

Mr. Richardson recused himself from this hearing due to a conflict of interest in this case. The recusal form was signed, and a copy was provided to the court reporter.

#### **Motion**:

Ms. Lineberger made a motion to go into Executive Session for legal advice. Mr. Lindler seconded the motion, which carried unanimously.

### **Motion:**

Mr. Williams made a motion to reject the Hearing Officer's Recommendation for 2018-383, as written, and instead issue a Letter of Caution for failing to obtain a permit prior to beginning work. Mr. Lindler seconded the motion, which carried unanimously.

Ms. Lineberger made a motion to accept the Hearing Officer's Recommendation for 2021-393, with the modification to add a Private Reprimand. Mr. Williams seconded the motion, which carried.

Mr. Richardson rejoined the meeting.

### Case No: 2021-305

Katherine Barroll, Office of Disciplinary Counsel, represented the State. The Respondent was not present at the hearing. All persons testifying were sworn in by the court reporter. In accordance with Board confidentiality statutes, the hearing was closed.

Mr. Appleton recused himself from this hearing due to serving as the hearing officer in this case. The recusal form was signed, and a copy was provided to the court reporter.

### **Motion:**

Mr. Lehman made a motion to accept the Hearing Officer's Recommendation, as written. Ms. Lineberger seconded the motion, which carried unanimously.

Mr. Appleton rejoined the meeting.

The meeting returned to open session.

### **APPLICATION HEARINGS**

# JM Mechanical (CLM.114940) / Jason McFadden (CQM.27992 PQ) - Reinstatement Application

The Mechanical Contractor's reinstatement application for their Group 2 Mechanical Contractor's License with the Air Conditioning classification and Mr. McFadden listed as the Owner and Primary Qualifying Party could not be approved at staff level due to having outstanding monetary judgments related to construction, questions related to his financial statement and whether he meets the statutory financial thresholds for the requested licensing group, and concerns over a previous Board Order, which denied licensure renewal. Mr. McFadden was present and was represented by Tracey Perlman, Esq. A quorum of the Board was present. All persons testifying were sworn in by the court reporter. Application hearings are recorded by a certified court reporter in the event a verbatim transcript is necessary.

### **Motion:**

Mr. Williams made a motion to go into Executive Session for legal advice. Mr. Walsh seconded the motion, which carried unanimously.

### **Motion:**

Ms. Lineberger made a motion to come out of Executive Session. Mr. Appleton seconded the motion, which carried unanimously.

It was noted for the record no votes were taken during executive session.

### **Motion**:

Mr. Appleton made a motion to deny the Mechanical Contractor's reinstatement application based on the number of judgements and the lack of evidence indicating that Applicant has made progress towards resolving the outstanding judgements. Additionally, Applicant failed to disclose the outstanding monetary judgements as current liabilities his owner prepared financial statements. Ms. Lineberger seconded the motion, which carried unanimously.

Jimmy L Davis Inc (CLG.12086) / Jimmy L. Davis (CQG.3136 PQ) – Renewal Application The General Contractor's renewal application for their Group 5 General Contractor's License with the Building classification and Mr. Davis listed as the Owner and Primary Qualifying Party could not be approved at staff level due to having outstanding monetary judgments related to construction. Furthermore, staff also had questions as to whether he meets the statutory financial thresholds for the requested licensing group. Mr. Davis was present and was represented by Townes B. Johnson, III, Esq. A quorum of the Board was present. All persons testifying were sworn in by the court reporter. Application hearings are recorded by a certified court reporter in the event a verbatim transcript is necessary.

### **Motion**:

Mr. Lehman made a motion to approve the General Contractor's renewal application. Ms. Lineberger seconded the motion, which carried unanimously.

### **Rescinded Motion:**

Mr. Lehman made a motion to rescind his previous motion to approve the General Contractor's renewal application with no conditions. Ms. Lineberger seconded the motion, which carried unanimously.

Gloss Painting Solutions LLC (CLG.) / Christopher Gloss (CQG.) – Initial Application

The General Contractor's initial application and Primary Qualifying Party initial application for a Group 1 General Contractor license with the Nonstructural Renovation classification and Mr. Gloss listed as the primary qualifying party could not be approved at staff level due to items

appearing on Mr. Gloss's criminal background report. Mr. Gloss was present and was not represented by counsel. A quorum of the Board was present. All persons testifying were sworn in by the court reporter. Application hearings are recorded by a certified court reporter in the event a verbatim transcript is necessary.

# Christopher Douglas Williams (CLG.) / Christopher Douglas Williams (CQG. PQ) – Initial Application

The General Contractor's initial application and Primary Qualifying Party initial application for a Group 2 General Contractor's License with the Building classification and Mr. Williams listed as the Owner and Primary Qualifying Party could not be approved at staff level due to items appearing on Mr. Williams's criminal background report. Mr. Williams was present and was represented by Dayne Phillips, Esq. A quorum of the Board was present. All persons testifying were sworn in by the court reporter. Application hearings are recorded by a certified court reporter in the event a verbatim transcript is necessary.

### **Motion**:

Mr. Appleton made a motion to approve the General Contractor's initial application and Primary Qualifying Party initial application with the condition that the applicant resubmit an updated and

appropriate financial statement or provide a surety bond. Ms. Lineberger seconded the motion, which carried unanimously.

# Smart Electric Company Inc (CLM.106027) / Christopher Ray McDaniel (CQM. PQ) – Primary Qualifying Party Application

The Mechanical Contractor's Primary Qualifying Party initial application to add himself as an additional Qualifying Party could not be approved at staff level due to items appearing on Mr. McDaniel's criminal background report. The company currently has a Group 5 Mechanical Contractor's License with the Electrical classification with Stephyn Smart listed as the Primary Qualifying Party. Mr. McDaniel was present and was not represented by counsel. A quorum of the Board was present. All persons testifying were sworn in by the court reporter. The company's current Primary Qualifying Party, Stephyn Smart, testified as a witness in this application hearing. Application hearings are recorded by a certified court reporter in the event a verbatim transcript is necessary.

The Mechanical Contractor's initial application and Primary Qualifying Party initial application for a Group 3 Mechanical Contractor's License with the Air Conditioning and Packaged Equipment classifications and Mr. May listed as the Primary Qualifying Party could not be approved at staff level due to items appearing on Mr. May's criminal background report, as well as concerns with conflicting experience documentation. Mr. May was present and was not represented by counsel. A quorum of the Board was present. All persons testifying were sworn in by the court reporter. Application hearings are recorded by a certified court reporter in the event a verbatim transcript is necessary.

### **Motion:**

Mr. Williams made a motion to go into closed session due to federal and state privacy laws. Mr. Lindler seconded the motion, which carried unanimously.

# L.B. Smith Companies, LLC (CLG.) / Larry E. Smith II (CQG.21178 PQ) – Initial Application

# Worthy Wizard Solar & Electric LLC (CLM.) / John Francis LaValley III (CQM.30371 PQ) – Initial Application

The Mechanical Contractor's initial application and Primary Qualifying Party revision application for a Group 2 Mechanical Contractor's License with the Electrical classification and Mr. LaValley listed as the Owner and Primary Qualifying Party could not be approved at staff level due to Mr. LaValley having his North Carolina license suspended and concerns with the fulfilment of the conditions imposed within that Order. Mr. LaValley was present and was not represented by counsel. A quorum of the Board was present. All persons testifying were sworn in by the court reporter. Application hearings are recorded by a certified court reporter in the event a verbatim transcript is necessary.

### Motion:

Mr. Lehman made a motion to approve the Mechanical Contractor's initial application and Primary Qualifying Party revision application. Ms. Lineberger seconded the motion, which carried unanimously.

## ASH Contracting LLC (CLG.113438) / Scott Thrane (CQG.15564 PQ) – Reinstatement Application

The General Contractor's reinstatement application for a Group 2 General Contractor's License with the Building Classification and Mr. Thrane listed as the Owner and Primary Qualifying Party could not be approved at staff level due to outstanding monetary judgments related to construction, having inaccurate or insufficient financial statement, and previous licensure discipline which resulted in suspension. Mr. Thrane was present and was not represented by counsel. A quorum of the Board was present. All persons testifying were sworn in by the court reporter. Application hearings are recorded by a certified court reporter in the event a verbatim transcript is necessary.

Mr. Walsh recused himself from this application hearing due to a potential conflict of interest. The recusal form was signed, and a copy was provided to the court reporter.

Mr. Williams made a motion to deny the General Contractor's reinstatement application. Mr. Marcum seconded the motion, which carried unanimously.

Mr. Walsh rejoined the meeting.

The General Contractor's initial application and Primary Qualifying Party initial application for a Group 1 General Contractor's License with the Building classification and Concrete Specialty subclassification and Mr. Callahan listed as the Owner and Primary Qualifying Party could not be approved at staff level due to Mr. Callahan having a previous license or certification disciplined in South Carolina. Mr. Callahan appeared virtually via WebEx per his request due to being out of the country and was not represented by counsel. A quorum of the Board was present. All persons testifying were sworn in by the court reporter. Application hearings are recorded by a certified court reporter in the event a verbatim transcript is necessary.
