Renewal Instructions/Requirements:

- Check or money order only in the amount of the renewal fee made payable to SCCLB. (All fees are non-refundable. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds.)
- Mail all items to the address above. (Use PO Box for regular mail; use street address for overnight mail.)
- A current **Certificate of Liability Insurance** (minimum amount \$100,000) on file with this office before the license can be renewed, indicating the SC Contractor's Licensing Board as the "Certificate Holder" on the form.
- If the licensee's Federal ID# or legal organization has changed since its last renewal, and it has not already filed a new initial application on Doc. #130, it may not renew the existing license and must complete Doc. #130.
