## Chair's Message

Welcome back to the S.C. Board of Cosmetology newsletter.

A lot of exciting things are happening in our industry. Many of our continuing education providers are bringing us new forums for learning. I would like to welcome two new continuing education providers: The S.C. Esthetics Association and the technical college providers. They are providing great



learning opportunities by offering more educational selections and more locations.

On a serious note, the nail industry has been making unfavorable news. First, there have been some outbreaks of Mycobacterium fortuitum in the state. As you know, clients contract this serious infection through unsanitary pedicure thrones. It is of the utmost importance that salon owners and nail technicians be diligent in disinfecting these chairs.

Also, as a result of a highly resistant staphylococcus aureus bacteria ("staph" infection) contracted during an unsanitary pedicure, a 46-year-old woman died in Forth Worth, Texas. After months of oral and intravenous antibiotic therapy, the staph attacked her heart resulting in death. A copy of the TV news story is listed in this newsletter. This is more proof that continuing education is needed. Clients should not have to worry about contracting a life threatening infection by simply visiting a salon for pampering services. Please don't let this happen in our state or your salon! As a reminder, you may find the proper method of disinfecting your salon on the Board's Web site – www.llr.state.sc.us.

Also, for the first time in several years, the Board is taking its meetings back on the road. In September, the Board met in Greenville. On November 13, we will be meeting in Columbia. The January 8, 2007, meeting will be held in Charleston. Locations will be announced soon. Please check back on our Web site for details. We are always happy to see new faces!

Due to job analysis surveys conducted throughout the country and effective April 1, 2007, Processional Credential Services (PCS) will be implementing the new esthetic and cosmetology exams developed by National Interstate Council (NIC). Look for a new nail technician and instructor examination to be released in 2007. Rest assured that NIC is always developing the best examination possible for our industry.

## **Common Violations Result in Sanctions**

As Board members, we take our profession seriously. All licensees should do the same. If you have violated the laws governing the practice of cosmetology, expect to be sanctioned.

Here is a list of common violations, with the associated fine, that the Board has directed inspectors to assess for each violation.

#### Allowing Unlicensed Practice

N 1' O C E' CC	\$500
Never licensed in S.C.– First offense	
Expired ind/ booth renter license - more than one year	\$200
Expired ind/ booth renter license - less than one year	\$100
Subject with no booth renter license	\$200

#### **Second Offense**

If you are found to have allowed unlicensed practice a second time, there will be a hearing to determine the appropriate sanction. You may also face additional penalties for violating terms of probation or for violating a cease and desist order.

Fines will be assessed against the salon license (<u>owner</u> of salon) for allowing subjects to work with expired licenses and no state license. Fines may also be assessed to the personal license of the <u>owner/manager</u> listed on the salon license. Cease and Desist Orders will be issued both to individuals working without a current license and to salon <u>owner/manager</u> that was allowing the violation.

- All corrections (name and address) must be submitted in writing. Corrections sent by fax are acceptable. The fax number is (803) 896-4484.
- To assist staff and management, if you need to call the Board office, always write down the name of the person with whom you spoke. This helps management validate that correct information is being distributed to licensees. If you leave a message, clearly state your name and phone number and repeat the information.

## **Pedicure Safety Reminder**

Never attempt to use a credo blade to cut or remove calloused skin. It is too easy to remove healthy skin along with the callous.

## **Computer-Based Testing**

As of May 1, 2006, Professional Credential Services (PCS) will be administering both written and practical examinations. Written exams will be solely computer based, with the exceptions of students needing special assistance.

### Family Believes Pedicure Led to Woman's Death

Something as simple as a pedicure is said to have been the cause of Kimberly Jackson's death.

An MRSA staph bacteria that's sometimes found in nail salons is very aggressive. Usually it causes open sores that take strong antibiotics over weeks or even months to knock down.

However, in some cases MRSA can lead to death and the family of the Fort Worth woman said that's what happened in this case.

Her husband, David Jackson of Fort Worth, said he still can't believe his wife is gone, and the cause of her death only adds to the agony.

"Something so stupid like a pedicure took her life," Jackson said.

The death certificate signed by the JPS Health Center doctor who treated her showed Jackson died from a heart attack due to a staph infection on her foot that infected her blood.

"She couldn't get it healed no matter what she was doing, and the antibiotics just wouldn't stop it," Jackson said.

Jackson's family said she went to a Fort Worth salon last July for a pedicure in a whirlpool foot spa. Jackson, a paraplegic, could pull her wheelchair up to the tub according to close friend and neighbor Patricia Mathis.

"She had said she had gone to get a pedicure and that they were all sitting there talking and she looked down and the girl

had the pumice stone turned on the corner edge and she pulled back and Kim saw blood," she said.

Medical records obtained by News 8 showed that over the next seven months the JPS doctor at a clinic treated Jackson for the MRSA staph infection on her foot from the cut.

MRSA is an aggressive bacteria resistant to common antibiotics and is sometimes found in the water of salon foot spas that are not disinfected properly.

The doctor put Jackson on a cocktail of strong oral and intravenous antibiotics.

"It got pretty big and she got pretty scared she was going to lose her foot," Mathis said.

But on Feb. 12, the 46-year-old woman lost her life.

At her funeral, friends and family remembered Jackson as the mother of 17-year-old boys, twin 13-year-old boys and the wife of a man who took care of her after she lost the use of her legs six years ago.

"It's hard," Jackson said. "Nobody has a clue. I mean everybody can say, I can only imagine. It's hard...It's real hard."

The family said it knows the salon where Jackson picked up the cut, but wants to confirm it through bank records.

The Texas Department of Licensing and Regulation that oversees nail salons said it will be investigating Jackson's death."

#### S.C. Code of Laws

Law/Regulation	Subject	Fine
40-13-110	Individual License Required	\$500
Any person practicing cosmetology should be properly licensed by the Board. Cease and Desist should be issued to any indi-		
vidual in violation. If an unlicensed individual is practicing, he/she will be fined and Social Security number obtained.		

40-13-280 <u>Display of License Required</u> \$100

First offense, warning issued. Individual licenses should be placed adjacent to or near his/her workstation. Salon license should be displayed in a conspicuous place.

40-13-290(B) <u>Inspection, Failure to Allow</u> \$500

Authorized agents may enter any salon or school at any reasonable time for purposes of inspections.

40-13-300 Unlicensed Salon \$500

The board should license any salon in operation. Application should be taken for a new salon license (\$100 fee) or a Cease and Desist should be issued for the shop to be closed.

40-13-300 Unlicensed Booth Renter \$200

The board should license any booth renter in operation. Application should be taken for new booth renter (\$100 fee) or a Cease and Desist should be issued for subject to stop working.

Regulation 35-20 <u>Violation of Sanitary Rules</u> \$100

Per workstation, if applicable.

## Meet the Cosmetology Board

#### **Rosanne Kinley**

Former S.C. Governor Jim Hodges appointed Rosanne Kinley to the Board in 1999. She is 45 –years old and married to Dan Kinley. They have three children and three grandchildren. A graduate of T. L. Hanna High School in Anderson, Kinley attended the College of Charleston and Anderson College. In 1985, she attended Esthetics International and became licensed in esthetics and nail technology.
