#### **DISCUSSION - POSSIBLE REGULATIONS FOR REVISION:**

- 1. 36-01 definitions
  - a. 36-01(1) revise the requirement that supervision be 75% face-to-fact and 25% HIPAA-compliant on-line technology
  - b. 36-01(5) revise to include addiction counselors
- 2. <u>36-05 Licensing provisions for professional counselors</u>
- 3. 36-07 licensing for LMFT associates
- 4. 36-07(3) (h) 100 hours of 500 hours of clinical contact supervision by an LMFT supervisor
- 5. 36-09 licensing provisions for LMFT supervisors
- **6.** 36-09(4) must supervision of supervision be by a LMFT supervisor? Or can it be a licensed qualified mental health practitioner (LPCs require LPC-S; LACs allow for other supervisor as approved by the Board).
- 7.  $\underline{36-12 \text{licensing for LAC-S}}$
- **8.** Correct typo references applying for licensure as a professional counselor supervisor, not an addiction counselor supervisor
- 9. 36-14 endorsement licensure
- **10.** 36-14(A) (1) revise to allow for substantially equivalent experience to be met by "X" years of licensed practice? Allow substantially equivalent experience and education to be met by passing board approved examination?
- 11. 36-15 revocation of expired licenses
  - a. Retitle to track language in statute lapsed instead of expired
  - b. Retitle to track language in statute reinstate instead of reactivate
  - c. Retitle to track language in statute provide proof instead of demonstration
  - d. Retitle to track language in statute submit instead of re-apply
  - e. Add addiction counselor
- **12.** 36-15(2) reconsider requirements for reinstatement after 2 years of lapsed to re-apply and meet all requirements at time of application for reinstatement? Perhaps to ease?
