Beginning in January 2014, the Fundamentals of Engineering (FE) and Fundamentals of Surveying (FS) exams will be offered year-round as computer-based exams at Pearson VUE testing centers. For additional information visit <a href="http://cbt.ncees.org">http://cbt.ncees.org</a>



## **Administrator Jan Simpson Retires**

Jan Simpson, Administrator for the Board of Professional Engineers and Surveyors, retired effective June 30, 2013.

Simpson has actively participated in NCARB regional and annual meetings since 1994, serving as a workshop presenter and panelist. # NCEES Credentials Evaluations Named Official Educational Credentials Evaluator for Records Program

The NCEES board of directors recently designated the organization's Credentials Evaluations service as the official educational credentials evaluator for its Records program. Beginning December 1, 2012, all NCEES Records applicants with degrees earned outside the United States from programs not accredited by ABET must have their educational background evaluated by NCEES Credentials Evaluations. Evaluations performed by any other service will no longer be accepted.

The board of directors approved the new requirement as its November 2012 meeting.

An NCEES Record contains the documentation needed for comity licensure, the process by which an individual licensed in one state applies for licensure in another jurisdiction. This includes college transcripts, exam and employment verifications, and professional references. NCEES collects and stores this information and then submits it to a state licensing board on the individual's behalf when he or she applies for comity licensure.

NCEES Executive Director Jerry Carter explained the reason for the change: "The majority of our member licensing boards only accept an NCEES evaluation when reviewing a licensure candidate, so this change will better meet the requirements of the state boards. We also hope that having a unified method for evaluations will improve the NCEES Records application process for our candidates and save them valuable time."

This change will not affect pending applications submitted prior to December 1, 2012.

## **Technology Degree Applicants**

Applicants holding a accredited degree must apply for registration through the Portfolio Application Process. This is a process especially designed to grant individuals with technology degrees a Category A (unrestricted) registration and applies to both new and comity candidates. In order to qualify for the process, applicants must have a TAC/ABET accredited degree and eight years of experience after obtaining the degree.

In order to apply for the process, applicants must first submit an application to the Board. Applications and forms can be obtained online at

<u>www.llronline.com/POL/engineers/index.asp?file=pub.htm</u> (scroll to the bottom of the page and download the forms under the heading labeled "Engineering Technology Graduates"). The application will be reviewed by a Board member for approval to enter the Portfolio Review Process.



Board staff will contact the applicant with guidelines and forms for submitting the portfolios when the application has been approved for the portfolio process. Portfolios must include three projects showing progressive experience, and hand calculations are required for each project. The projects can be submitted on CD per the instructions transmitted to the application upon approval for the process. Applicants should provide six copies of the portfolios and should maintain one copy to bring to the committee review and interview.

Once the portfolios are received, Board staff will send a confirmation to the applicant and will schedule a date for a portfolio review and interview. A five -member committee will be formed based on the applicant's discipline. A date will be scheduled for the committee to review the portfolio and interview the candidate. Applicants for this process must appear before the committee for an interview in order to complete the process. Reviews and interviews are held at the Board office in Columbia, SC. Committees are typically formed in the spring and fall of each year. Applicants will be given at least two weeks notice of the review and interview date so travel arrangements can be made. The committee will make a recommendation to the Board, which will be reviewed for registration at the next scheduled Board meeting. Applicants are welcome to attend the Board meeting, but this is not required to complete the process.

This is a lengthy process that can take up to six months to complete, so it is best for applicant to submit applications well in advance of anticipating work in

Portfolio Committee Members Needed

The Board is always in need of volunteers to serve on the Portfolio Review Committees. Committees are formed by discipline and typically meet twice a year (spring and fall) to review candidates for registration through the portfolio review process. The review process has been streamlined for more efficiency. Submissions are now being accepted and transmitted electronically. Another change is that the review and interview meetings have been combined, so committee members will only be required to travel to the Board office in Columbia one time for each review session.

Committee members will receive mileage reimbursement and one hour of continuing education for each hour they spend at the Board office performing reviews and interviews. Applicants for all disciplines are now being accepted. The Board is in particular need for volunteers in the area of civil engineering and fire protection.
