Board Meeting-September 12, 2006

The Board held a regular scheduled meeting on September 12, 2006, at 110 Centerview Drive, Synergy Business Park, South Carolina.

Board Chair, Frankie Burden, called the meeting to order at 10:05 a.m. The invocation was given by William Armes. Discussion of a Lab Committee

Discussion of a Lab Committee was tabled until the November 28th meeting. Chairman Burden asked that prior to the next meeting, John Young will submit in writing, an outline of recommendations for lab certification experience requirements, to be forwarded to the board members for their review.

Discussion of Direct Supervision for "Trainee" Operator Certification

Becky Dennis, Kiawah Island Utility, spoke on behalf of Jim Matthews, who was unable to attend the meeting. She stated their primary concern is the criteria that is being mailed out states that a trainee is permitted to work only when a "D" "C" "B" or "A" level operator is present and supervising the work, and this is contradictory to the law. She referred to Section 51-5A of the Regulations: "Operation under this permit shall always be under the direct supervision of a legally licensed operator of the proper grade." Section 51-7 which reads:" Direct Supervision" means supervision provided by a licensee who must (a) be on-site or immediately available to supervise persons via telephone, radio, or other electronic means; and (b) maintain continued involvement in appropriate aspects of each professional activity of the supervisee." Dona Caldwell, Administrator, said she thought the confusion was coming from the Definition of "Direct Supervision" used for Well Drillers. Dona, stated when the regulations were being changed, a public hearing was held, several special interest groups requested that a provision be added for large facilities that would encompass a large area of land. This would allow the Operator of Record not to have to sit at the operator's shoulder, they would be able to encompass that facility. Dona stated "Direct Supervision" of operators is being misinterpreted as meaning you do not have to have a supervisor present, all you have to do is have telephone or radio contact. Legal Counsel: Rick Wilson stated, for clarification of the definitions, Becky should refer to the law. He said the board's definitions apply to everything that is in Chapter 23. Rick stated that changes can be made on the information mail out sheet but any language changes regarding the law will have to be made through regulation. Dona stated the information sheet that is currently being sent out, will be changed.

Election of Officers

<u>Motion:</u>Chair, Frankie Burden, nominated Mike Bailes as Chairman. The motion was seconded by Dwight Johnson. Approved.

<u>Motion:</u>Mike Bailes, nominated William Armes as Vice-Chair. The motion was seconded by Chairman, Frankie Burden. **Approved.**

Investigator's Report for May, July & September

The Investigator's Report was given by Dona Caldwell, Administrator, in the absence of DeLeon Andrews, who was unable to attend the meeting. She said that Dwight Hayes, Legal Counsel, suggested the board appoint a hearing panel with hearing officers (former board members) to hear cases, and make recommendations to the board. She suggested this as an item of discussion at the next meeting.
