1. **Regulatory Review for Approval.** Mr. Tuck said the previous version of the proposed regulation changes had the entirety of Section 51-5 stricken, but this needs to be addressed for the trainee

licenses. The section has been amended to remove the strike-through and amend the text to read For biological wastewater treatment operators, physical/chemical wastewater treatment operators, water treatment operators, and water distribution operators the board shall issue "trainee" licenses for new personnel with qualifications as stated in 51–3. Operation under this license shall always be under the direct supervision of a legally licensed operator of the proper grade. All applications must be endorsed by the applicant's chief operator, or operator-in-charge."
