Chair's Remarks - Ken Rentiers

Chair Rentiers introduced the purpose of the special called meeting: to discuss new information regarding unanticipated fallout from the board's decision to lower the passing threshold for exam scores.

New Business

Reconsideration of the July 25, 2024 Board Vote to Lower the Examination Passing Score(s) from 70% to 60% – Molly Price, Program Director

The Board discussed the following the decision to lower the passing scores, WPI has indicated that they have been internally considering not allowing South Carolina to utilize their exams anymore. Additionally, the EPA has indicated that the state's Drinking Water Revolving Fund would need to be reconsidered.

MOTION: To remove the 60% passing threshold for exams and return to the 70% passing

threshold.

Public Comments

Robert Schmidt spoke in favor of the decision to return the exam passing scores to 70%, expressing concerns about the quality of operators and the importance of maintaining high standards within the community. He elaborated that low interest in the field is due to low pay rates within the field, which must be adjusted by the market.

Paul Calamita spoke against the decision to return the exam passing scores to 70%, emphasizing the need for legal advice and a clear understanding of the contract with WPI.
