# Staff Reports

- a. Administrative and Financial Report Johnnie Rose
  - i. Mr. Rose introduced Cleve Langdale as the new Program Coordinator, and Robbie Dean as the new lead investigator. Robbie Dean is also one of the four investigators assigned to the Board.
  - ii. There are 666 registered foresters.
  - iii. Six licenses were issued since the last meeting: five by examination, and one by

- reciprocity.
- iv. License and pocket cards are updating to an 8.5" x 11" card and certificate.
- v. The Board is now in late renewals, which are open through September 30, 2023, with a \$50 late fee.
- vi. Mr. Rose has contacted the Association about the three expired Board member terms. Mr. Sligh has been reappointed.
- vii. The Board had a cash balance of \$51,127.13 as of May 31, 2023.
- viii. The next Board will be November 16, 2023. It will be an in-person meeting held at the SC Department of Labor, Licensing and Regulation at 10 a.m.

- c. ODC Report Mr. Rose reported no cases in the Office of Disciplinary Counsel.
- d. OIE Report Mr. Dean reported no cases in the Office of Investigations and Enforcement
- **e.** IRC Report Mr. Dean said there was no Investigative Review Committee report.

#### **New Business**

a. **Update for Proposed Changes of Chapter 53, Notice of Drafting – Mary League**Mrs. League stated the Regulatory Review decision to revise 53-4 regarding quorums was published in the State Register on March 31, 2023. The current language states that four members constitute a quorum, but the Board voted to change this to "a majority of the members serving constitutes a quorum."

**MOTION:** To approve this change.

#### b. H.3605 Review and Vote - Mary League

Mrs. League stated that H.3605 passed the legislature in the 2023 session. This legislation has three parts:

- First, licensure will be granted upon completion of an apprenticeship program, unless the statute requires a baccalaureate degree or higher for licensure. The Board will not be affected since there is a degree requirement for licensure.
- Second, criminal convictions cannot be the basis of denial or restriction of licensure unless the offence directly relates to the practice of the profession or occupation. The Board must articulate a reason if they do deny or restrict a license on this basis. Another part of this is that vague language referring to "moral turpitude" or "good character" is confusing to potential licensees and must be removed.
- Third, the name of a complainant must be released to the respondent unless the complainant provides good cause to withhold their name. These petitions will be reviewed and approved by a Board member.

**MOTION:** To designate Mr. Maley to review "good cause" complaint cases.
