## SC Forestry Commission's (SCFC) 2016 Southern Pine Beetle (SPB) Pheromone Survey and SPB Program



This year's SPB Pheromone Survey is complete and the results have been placed on SCFC's website. SPB numbers are still low for the whole state and little to no SPB activity is predicted for 2016. However, the SPB catch was 400% more than what it was in 2015, which may indicate the SPB population decline since 2003 may be stabilizing. Even though SPB activity is currently low, SCFC's SPB Program has cost-share funding available for low-density planting of longleaf (8' X 10') and loblolly (9' X 10') on previously pine forested sites and for pre-commercial thinning young, overly dense (>700 pine/acre) pine stands. ## Exam Information

As of January 1, 2016, individuals interested in becoming a **Registered Forester by Examination** will take a two-part examination for licensure in South Carolina.

Part One: Certified Forester (CF) Examination (150 multiple-choice questions) Part Two: South Carolina Forestry Specific Examination (35 multiple-choice questions)

Applicants must obtain a passing score of 70% on the South Carolina Forestry Specific Examination.

Applicants must obtain a scale score of 75 for passing on the CF Examination.

LLR offers licensees many great online services. You can check the status of your application, change your address, and print pocket cards. You can avoid paying \$5 for a duplicate pocket card by printing one right from the website.

## Don't Forget About your Continuing Forestry Education

Each registered forester is required to obtain 10 Continuing Forestry Education (CFE) credits annually. A minimum of five credits must be acquired in Category 1. A maximum of five credits in categories 2-6 may be carried over for one year. 20 CFE credits must be obtained during each licensure period (ie. July 1, 2015- June 30, 2017).

To help licensees keep track of their CFE credits, the Board has created a CFE Reporting Form. This form will also be used as part of the upcoming CFE Audit for the 2015-2017 licensure period. ## Meet LLR's Interim Director



Emily H. Farr was appointed as the interim director of the South Carolina Department of Labor, Licensing and Regulation by Governor Nikki R. Haley on August 8, 2016. Farr is awaiting Senate confirmation.

Farr came to LLR from Haynsworth Sinkler Boyd, P.A., where she focused on employment advice and counsel, consumer financial services litigation, and title insurance defense.

While at the law firm, Farr provided advice and counsel to human resource professionals and employers to identify practical solutions to workplace issues, including drafting company policies and procedures, assisting with the preparation and implementation of employee handbooks, and preparing restrictive covenants severance agreements and independent contractor agreements.

Farr's practice also included title insurance litigation, handling a variety of real estate litigation matters such as quiet title actions, deed and mortgage reformation actions, and lien priority issues. She also handled financial litigation, which involved an array of business and banking matters under federal law, such as the Fair Credit Reporting Act and the Truth in Lending Act, and state law, such as the South Carolina Consumer Protection Code and statutes addressing predatory lending.

## Frequently Asked Questions

### **What is the Cost of Registration as a Forester?**

The application fee is \$50 and the registration fee is \$130 (two-year license fee). The registration fee is prorated for applications received after April 1<sup>st</sup> of the year prior to renewal (2014, 2016, etc.). The prorated registration fee is \$65.

### **What are the Renewal Fees for 2017-2019?**

SC Code of Regulations, Chapter 53-16 has been updated to reflect the fees for the Board as of July 1, 2016. The two-year license renewal fee is \$130 and will be due by June 30, 2017. Reminder notices will be mailed to all active licensees in April 2017.

### **Does South Carolina Grant Reciprocity to Foresters Who Are Registered in Other States?**

Yes. Reciprocity is considered for those applicants coming from states with laws compatible with South Carolina's. Foresters who have not taken and passed an examination for registration may have to take the South Carolina exam. Licensure by Reciprocity is assessed on an individual basis.

### **How Do I File a Complaint?**

Licensees perform valuable work for the public as professional foresters in the State of South Carolina. The majority of licensed professionals are competent, skilled practitioners, and you are a witness to their good work. In the course of your work in this state, you may also witness work or processes that don't meet the requirements licensees must uphold, or find work performed by unlicensed individuals.

Licensees play an important role in safeguarding the public, and the Board relies on you to advise us when you encounter unprofessional, unethical, or unlicensed activities. We encourage you to file a complaint with the Board if you witness a possible violation. The Board can accept anonymous complaints and pursue them if the related information or documentation is publicly available, if you do not wish to be the formal complainant.

The public relies on you to file a complaint if you suspect violations of Board's statutes or regulations. It is not taken lightly, and will be investigated in a timely manner.
