### **Renewal Instructions/Requirements:**

- Renewal fee in the form of a check or money order (no cash) made payable to LLR-Board of Funeral Service. (All fees are non-refundable. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds.)
- Renewal / Late Fees:

Postmarked 10/31/20 or before: \$350

Postmarked 11/1/20 or after: Late fee 120 + Renewal Fee 550 = 470

After November 1, 2020, the license must be reinstated. Continued practice may result in disciplinary action.

• Manager must be renewed either with or before the Funeral Home.
