- Renewal fee in the form of a check or money order (no cash) made payable to LLR-Board of Funeral Service. (All fees are non-refundable. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds.)
- Renewal / Late Fees:

Renewed/postmarked on or before 7/31/2022: \$350 Renewed/postmarked on or after 8/1/2022: Late fee \$120 + Renewal Fee \$350 = \$470

After August 1, 2022, the license is expired and must be reinstated. Continued practice may result in disciplinary action.

• The manager license must be renewed before the funeral establishment's license can be renewed. Please allow 24 hours between the manager and facility renewals.
