#### 7. Chairman's Remarks - Chuck Gorman

Chairman Gorman welcomed Andrew Rogers, newly installed as Assistant Deputy Director. Mr. Rogers is formerly from Office of Disciplinary Counsel.

Chairman Chuck Gorman also welcomed new board member, Duke Brantley, PhD from USC, who currently works at the Earth Sciences Research Institute (ESRI) at USC.

The incumbent board members then introduced themselves:

- Chairman Gorman works for DHEC, holds a Geology degree from USC and a Master's from University of Utah.
- Vernon Ichimura is the board member representing companies. His specialty is groundwater. He holds a
  Bachelor's degree in geophysics from University of Hawaii, a Master's in geology from Washington State,
  and a PhD in Civil Engineering also from Washington State.
- Mark Taylor works for SynTerra, has an undergraduate degree in geochemistry from Harvard and a Master's from University of Michigan.

# 8. Administrator's Report

# A. Financial Report

The Board expressed concern over the expenses allocated to the Board and asked Doris to provide additional information at the June Board meeting. Vernon Ichimura asked to have a comparison of FY13 and FY15 to see what has changed. Doris explained that the process to increase rates has to be approved through Director's office and then a bill has to be filed in Regulations to be passed by the Legislature.

#### B. Licensee update

There are currently 589 Registered Geologists and 15 Geologists in Training for a total of 604 licensees. Doris received an e-mail about an administrator's workshop November 1, 2016, but she has another obligation at the time. The board could send a staff member if they would like.

ASBOG has put out a white paper about the EPA coal ash disposal rule to show the professionalism of Geologists.

# C. Transferring responsibility of proctoring licensing/professional exams

Due to many reasons, mainly liability, LLR wants to have all professional exams proctored by a third-party, such as PSI. Doris had contacted Deana Sneyd at ASBOG and was told ASBOG has no issues with this and that several other states already do this. We currently are charging \$150 for the Fundamentals of Geology exam and \$250 for Practice of Geology exam. Virginia is using PSI, charging \$190 for the Fundamentals of Geology exam and \$290 for the Practice of Geology exam. Pennsylvania is charging \$350 for Practice of Geology exam and \$250 for the Fundamentals of Geology exam. Utah is also using PSI and charging \$190 and \$290 for the Fundamentals of Geology exam and Practice of Geology exam respectively.
