## 5. Approval of Meeting Minutes

## 7. Application Hearing

a. Reexamination Application Hearing - Janice Porter

Elizabeth Schaper made a motion to approve Ms. Porter to retest. Dennis Lofe seconded the motion, and it carried unopposed.

### b. Reexamination Application Hearing -Angela Coleman

Angela Coleman appeared before the Board, for a reexamination application hearing. She was not represented by counsel, waived that right on the record, and was sworn in by the court reporter.

Angela Coleman presented her case to the Board and asked to be allowed another opportunity to sit for the exam after failing 5 prior attempts.

#### 8. Finalize Changes to Long Term Health Care Administrators Regulations- Chapter 93

Annette Schaper made a motion to move forward with the amendments made to the Long Term Health Care Administrators Regulations- Chapter 93 at the Work Session on August 27, 2025. Edward Burton seconded the motion, and it carried. Denise Lofe opposed.

#### 9. Delegation of Authority to Review and Approve Re-examination Application Request(s)

Melissa Yetter made a motion for the Board Executive to approve Re-examination Applications as long as the applicant's scores are showing improvement with a cap at the sixth attempt. Whether improvement or not, at the sixth attempt, the applicant must appear before the Board. Elizabeth Schaper seconded the motion and it carried unopposed.

## 10. Board Guidance on the Completion of the AIT Program

Melissa Yetter made a motion to approve the completion of AIT participants, who were previously approved with preceptors that had expired permits and that moving forward the preceptor must have a current permit. Patrice Deas stated that these AIT approvals with expired preceptor permits were done by previous staff prior to her taking over the Board. Mrs.

Deas assured the members of the Board, that her new staff is aware of making sure that preceptors have an active permit if they are going to precept anyone. These provisions are in place to mitigate this error from occurring going forward. Dennis Lofe seconded the motion and it carried unopposed.
