### **Meeting Called to Order**

#### Administrator's Remarks

Molly Price stated that the Board voted at the December 10, 2019, meeting to form a committee to review the Purchase Agreement/Form 500 used by retail dealers for the sale of new or used manufactured homes and to provide the Board with a recommendation for a standard form that would be available for use by all dealers statewide in accordance with Section 40-29-320, which says, "purchase agreements used by retail dealers for the sale of new or used manufactured homes must be standard and, in a form, prescribed by the board." Committee members received copies of a 2001 Purchase Agreement Memo from former administrator David Bennett, a blank purchase agreement from Jenkins Business Forms, a sample sales agreement from Clayton Homes, a sample addendum to the sales agreement form, and a blank Purchase Agreement from Southland Homes of Greenwood, Inc.

## **Review of Purchase Agreement Required Information (Form 500)**

The Committee discussed revisions to the Purchase Agreement, based on the examples that were provided. The Board will be informed of the suggested changes at their next meeting and the committee will meet again soon to continue review of the document.
