## **New Business**

Review/Approval of Applications

1. Francisco Javier Castellanos

Mr. Dwight Hayes stated Mr. Castellanos had been arrested on a charge of Battery against the Elderly. He further stated staff has brought Mr. Castellanos before the Panel for a recommendation for licensure.

Mr. Castellanos briefly explained the charge and indicated he spent six months in jail because he could not post bail. He stated he made a plea bargain in the matter and the charge was dropped. He answered questions the Panel members asked of him.

The Panel determined it would discuss this matter in executive session.

## 2. Tonya Lynn Huggins

Mr. Hayes stated Ms. Huggins has an arrest record that indicates she has been charged and convicted of illegal use of the telephone and shoplifting.

Ms. Huggins briefed the Panel members on the circumstance surrounding her arrests.

## Francisco Javier Castellanos

## **MOTION**

Ms. Pearson moved the Panel grant Mr. Castellanos a South Carolina license for Massage

Therapy for a probationary period of one year contingent the condition regarding no violations to the Massage Therapy Practice Act and the Panel also wishes Mr. Castellanos keep LLR informed regarding his employment and current address on a quarterly basis. Ms. Masters seconded the motion, which carried unanimously.

# Tonya Lynn Huggins MOTION

Ms. Pearson moved the Panel grant a South Carolina Massage license to Tonya Lynn Huggins for a period of two years in probationary status contingent upon of a favorable recommendation from her current counselor in regards to her competency to practice massage therapy and this license is also contingent upon keeping LLR informed on her employment and current address on a quarterly basis during this probationary time. The motion was seconded by Ms. Brewer and unanimously carried.

Web Site and Internet Options - Blain Mosher

Mr. Blain Mosher, Administrative Assistant, reviewed the agency's website with the Panel members.

## Disciplinary Process - Larry Hall

Mr. Larry Hall, Staff Investigator, reviewed the disciplinary process with the Panel members. The panel discussed massage therapists advertising in the newspapers without their license numbers. Ms. Masters asked if general counsel could write a letter to The Greenville News and indicate that according to state law license numbers must be used in advertising. Mr. Hayes stated staff could advise the newspaper, however, staff could not make them require licensure. During this discussion it was brought out that Bell South charges an extra \$16 per month for advertising.

The panel also discussed consent orders issued by staff.

## **MOTION**

Ms. Masters moved that in the Panel's next newsletter that the Panel begin publishing disciplinary actions that have been brought, any violations and list the name and address and a statement regarding altering or defacing a license. Ms. Pearson seconded the motion, which carried unanimously.

# "Energy" Disciplines

Ms. Dianne Postnic spoke to the Panel regarding "Energy" movements. She indicated that in 1983 she graduated from a training program which taught Feldencrias and she has been in private practice since that time in South Carolina and North Carolina. She further stated that individuals who perform Feldencrias do not perform soft tissue manipulation and that their primary objective is as instructor. She noted that although they do not perform soft tissue manipulation, they may touch an individual as way of instruction. She indicated that Feldencrias does not fall under the category of massage therapy. She asked the Panel to consider word a sentence in the Practice Act to allow her to work under the massage therapy practice act. She indicated that there are six other states

which allow the "energy" movements under their massage therapy practice acts.

## Breast Massage and Draping Procedures

Ms. Porter stated that there are workshops regarding breast massages and now it seems that there are male massage therapists who continue to do breast massage for people who may not need them. She asked the Panel how it could address the issue of therapeutic breast massage for individuals who may not need it.

Ms. Masters moved the Panel enter executive session to seek legal advice regarding breast massage and draping procedures. Ms. Pearson seconded the motion, which carried unanimously.
