APPROVAL OF AGENDA:

Motion: Ms. Gloria Lee Smith made a motion to approve the Massage Board Meeting minutes from August 4, 2023 with the corrections. Ms. Janet Shaw seconded the motion and it carried.

Chairperson's Remarks: Janet Shaw

She welcome new Board Executive Matalie Mickens. Thanked Theresa Brown for all of her efforts in the success of the Board running smooth.

Ms. Gloria Lee Smith and Ms. Janet Shaw and a few other were able to attend the FSMTB meeting. They gained a lot of useful information to bring back to the board.

Ms. Janet Shaw made the following statement regarding Massage therapy scope of practice:

The board has received questions regarding certain practices and devices and whether they are within the scope of practice of a Licensed Massage Therapist. Ms. Janet Shaw read a statement of the scope of practice, The Board's practice act in Code Section 40-30-30 provides the following definitions:

40-30-30(15) states: massage therapy means the application of a system of structured touch to the soft tissues of the human body with the hand, foot, knee, arm, or elbow, whether or not the structured touch is aided by hydrotherapy, thermal therapy, a massage therapy device, or application to the human body of an herbal preparation.

40-30-30(10) states: hydrotherapy means the use of water, vapor, or ice for treatment of superficial tissues. 40-30-30(18) states: thermal therapy means the use of ice or a heat lamp or moist heat on superficial tissues. 40-30-30(13) states: a massage device means a mechanical device that mimics or enhances the action of the hands by means of vibration.

Any devices or practices that do not fall within those definitions are not considered within the scope of practice of a licensed massage therapist, and cannot per performed by an individual representing themselves to be a licensed massage therapist.

HOWEVER, the Board takes no position on whether or not those types of procedures or the use of those devices can be done by an individual pursuant to other licensure or supervision, or by unlicensed individuals who do not represent themselves to be a massage therapist.

The board will provide a scope to the OIE for their records.
