Review for Consideration of Continuing Education Provider

Julie Rehoric

Julie Rehoric appeared before the Panel seeking approval to provide continuing education. Ms. Rehoric has an Associate's degree but she does not meet the requirements of South Carolina Code of Regulation Chapter §77-120 to teach ethics. Ms. Rehoric stated she has been a nurse for over 30 years. It was explained that she has conducted some research and found out that an Associate's degree is needed to teach the A & P component and hold a

Massage Therapy license for three years to teach Massage Therapy. Ms. Rehoric would like to incorporate certain ethical statements while teaching the continuing education classes.

Review for Consideration of Endorsement

John Pettit

John Pettit appeared before the Panel seeking approval of the endorsement massage therapy application. The discussion included but was not limited to explanation pertaining to endorsement of the massage therapy licensure. Mr. Pettit did not complete a national examination. Mr. Pettit is currently licensed in Pennsylvania and North Carolina. He graduated from a massage school in Pennsylvania during that time the examination to obtain licensure was

not required. When Mr. Pettit applied for licensure in North Carolina, he was required to submit written statements from three of his clients. Mr. Pettit received two sworn statements from medical physicians, a chiropractor who was clients of his and one of his instructors from the school in Pennsylvania. Mr. Pettit is certified in six levels of neurologic muscular therapy.

Isabella Schnittger

Isabella Schnittger appeared before the Panel seeking approval of the endorsement massage therapy application. The discussion included but was not limited to explanation pertaining to endorsement of the massage therapy licensure. Ms. Schnittger's secondary education as well as the massage therapy training was completed in a school in Germany. English is Ms. Schnittger's second language. William Vetter, Ms. Schnittger attorney accompanied her to assist with answering any questions the panel had. Mr. Vetter explained Ms. Schnittger attended massage school in Germany for 1800 hours which was a 12 month program. Once Ms. Schnittger successfully completed massage school licensure was received in Germany. After the license was received it was required to complete a two year and a half apprenticeship. Ms. Schnittger worked at various clinics in Germany and France. Ms. Schnittger moved to South Carolina because her husband's job re-located them to South Carolina. Mr. Vetter explained Ms. Schnittger's education and experience supersedes the South Carolina's requirements, and Ms. Schnittger will be an asset to the Massage/Bodywork Therapy industry.

Linda Gaskin-Drechesler

Linda Gaskin-Drechesler appeared before the Panel seeking approval of the endorsement massage therapy application. The discussion included but was not limited to explanation pertaining to endorsement of the massage therapy licensure. Ms. Gaskin- Drechesler received the massage therapy license without having taken a national examination. Ms. Gaskin- Drechesler completed her education from the United Kingdom. Ms. Gaskin- Drechesler has a current license from the State of Maine. The State of Maine does not require a national examination. In 2000 Maine accepted Ms. Gaskin- Drechesler education and experience for licensure. Ms. Gaskin- Drechesler taught aroma therapy classes. Ms. Gaskin- Drechesler husband, Jeffery Drechesler appeared as a character witness. Ms. Gaskin- Drechesler explained she attended massage therapy and aroma therapy school in England in 1995 and successfully completed 600 hours in massage therapy and 600 hours in aroma therapy. In the UK a massage therapy license is required to practice alongside a physician. In 2006 Ms. Gaskin- Drechesler re-located to Florida where she was a spa director. She did not work as a massage therapist in Florida. Ms. Gaskin- Drechesler is currently employed as an office worker at the International Spa Institute in Bluffton, South Carolina.

Mr. Bailey is interested in sports therapy and decided to further his education in sports massage therapy. To receive licensure in the United Kingdom the school must be accredited. Once the education is completed at the accredited school a license is granted to the students. Mr. Bailey is willing to take the required examination to receive his South Carolina license.
