5. Committee Recommendations for Vacancies (A-C)

Mr. William Sean Irvin, PA and Ms. Catherine A. Gillespie, PA were acknowledged for new Physician Assistant Committee positions, Mr. Irvin becoming new Chairman and Ms. Gillespie becoming new committee member. Dr. Brown James McCallum was present to answer questions regarding his interest in filling the Committee vacancy. Ms. Gillespie made a motion to go into executive session. Motion was seconded by Ms. Seel. After further discussion, a motion was made by Ms. Gillespie to come out of executive session and was seconded by Ms. Seel. Once out of executive session, a motion was presented by Mr. Irvin to accept Dr. McCallum’s application and present his name to the full BME to fill one of the physician vacancies on the Physician Assistant Committee. The motion was seconded by Ms. Gillespie and all favored. Ms. Brown informed the committee that prior to committee meeting starting, she was notified by Dr. R. Daren Marionneaux that he was no longer interested in joining the committee and wished to remove his name from consideration/ Dr. Marionneaux was not present at meeting.

6. Election of Officers: Vice Chair and Secretary

Mr. Irvin and Mr. Spoon both explained each job duties for both Vice Chair and Secretary. The floor was then opened to the other members to volunteer to fill positions. Ms. Hill offered to fill committee secretary vacancy. Motion was made to appoint Ms. Hill as secretary by Mr. Irvin. Ms. Seel seconded and all favored. Further into discussion, a motion was presented by Ms. Hill to recommend Dr. Stephen Gardner as Vice Chair pending his acceptance. Ms. Hampton seconded motion and all favored.

7. Standard Scopes of Practice (A-C)

Neonatal ICU, Neurology and Critical Care Scopes were proposed by, Megan Fulton, Director of Physician Assistant Practice, MUSC Health, via teleconference to be taken into consideration as standard board pre-approved scopes. After further discussion, a motion was presented to approve the Neurology scope as submitted. Ms. Gillespie and Ms. Hill seconded motion. Another motion was then made to table for revision of the Critical Care and Neonatal ICU scopes and was seconded by Ms. Hampton. All favored.

8. Physician Assistant Scope of Practice Guidelines Portal

Ms. Brown presented screen shot copies of the new Physician Assistant Scope of Practice Guidelines Portal and copies of the new documents associated with the portal. She explained and answered questions regarding the portal and new processing system.

9. Chair Report and Administrator's Report

Mr. Spoon informed the Physician Assistant license renewal ends December 31, 2019 mentioned CE Broker as available for licensees to track CME.

Dr. Gardner's suggestion for biannual committee meetings was discussed. A motion was made by Ms. Gillespie to move to biannual committee meetings, January and July of each year. Motion was seconded by Ms. Seel. All favored.

Ms. Hill made a motion to adjourn at 4:05 p.m. Ms. Gillespie seconded the motion which passed unanimously.
