## 5. Requests for Additional Skills

PA Drasti Smyre and Dr. Ashli O'Rourke teleconferenced in to the committee in regards to an Additional Skills Request application that was submitted before the board to request approval of Modified Barium Swallow. After further discussing application with Ms. Smyre and Dr. O'Rourke, a motion was made by Dr. S. Gardner to approve application. Motion was seconded by Ms. M. Hill. All favored for approval.

## 6. Standard Scopes of Practice

PA Kristin Richardson and Dr. Fred Norman teleconferenced in to the committee meeting in regards to a submitted Diet and Regenerative Medicine scope. Ms. Richardson and Dr. Norman both explained and answered questions about the scope from members. A motion was made by Dr. S. Gardner to defer the scope application until recommended changes by the committee have been made to the scope and resubmitted. Dr. B. McCallum seconded the motion all favored.

PA Rachel Greenfield teleconferenced in also to explain scope her originally denied submitted scope that lacked presentable scope template and job task/duties information. After explanation of scope and discussion from Ms. Greenfield, a motion was made by Dr. S. Gardner to defer the scope application until recommended changes and completion of scope have been made and resubmitted. Dr. B. McCallum seconded motion and all favored.

Mr. S. Irvin wanted to present PA Ryan Marovich's previously approved scope as a template to the other committee members in clarifying PAs Controlled Substance status. This was more so an informational item for the committee members from Mr. Irvin.

Motion was seconded by Dr. B. McCallum. After discussion amongst committee members and advice counsel, a motion was made by Dr. S. Gardner to come out of executive session and Dr. B. McCallum seconded. Another motion was made by Dr. S. Gardner to accept Dr. William O'Quinn's application and present his name to the full BME to fill the physician vacancy. The motion was seconded by Ms. C. Gillespie. Thereafter, Ms. C. Gillespie then made a motion to accept PA Derek Roper's application and to present his name to the full BME to fill the physician assistant vacancy. Ms. M. Hill seconded the motion and all favored for both candidates selected.

Mr. S. Irvin announced his committee term expired effective June 01, 2020. Pending full BME approval, Mr. Derek Roper will take his physician assistant seat and Dr. S. Gardner will then become the new Physician Assistant Committee Chairman.
