## Meeting Called to Order

Public notice of this meeting was properly posted at the South Carolina Board of Medical Examiners Office, Synergy Business Park, Kingstree Building and provided to all requesting persons, organizations and news media in compliance with Section 30-4-80 of the South Carolina Freedom of Information Act.

## Agenda - Monday, November 5, 2018

President's Report- Jeff A. Welsh, M.D.-Review and approval of Agenda; Approval of August 2018 minutes. Motion Dr. Saad. Second Dr. Schabel. Motion carried. Review and approval of excused absences. [n/a]

- a. Emily Farr, LLR Director, appearing. Director Farr appeared to address the board briefly, thanking the board for their service, provided her contact information and offered her assistance to the board in her capacity as agency director.
- b. Review of Joint Prescribing Guidelines Advisory Opinion-August 2017. After discussion, the board approved revisions to the Joint Prescribing Guidelines Advisory Opinion of August 2017. After approval by the three affected boards, the updated version will be posted on the LLR and board's webpage.
- c. Dermatology and Laser Center of Charleston, Dr. Todd E. Schlesinger-request for waiver of supervision requirements. After discussion, the board did not approve this waiver.
- d. Question regarding e-visits- Dr. Cook asked a question as to the permissibility of an e-visit model under the S.C. Telemedicine Act versus prescribing based on a questionnaire in the scenario presented by Dr. Cook. After extensive discussion, the board passed a motion to review and update the board's existing telemedicine advisory opinion. Drs. Welsh, Cook, Wright, Januchowski will participate.
- e. Proposed Regulations regarding adoption of AMA Code of Ethics. After discussion, the board passed a motion to withdraw the proposed regulation.
- f. Legislative Update-Holly Beeson, Rebecca Leach, LLR Office of Communications and Govt. Affairs. Holly Beeson and Rebecca Leach appeared to present the legislative update. The board discussed the possible upcoming introduction of a bill to require physicians to reimburse the JUA and medical marijuana.
- g. Proposed changes to the PA practice act, Kevin Harmon, SCAPA legislative chair-Kevin Harmon and Jennifer Marshall of SCAPA appeared to present proposed legislative changes to the PA practice act. After discussion, the board passed a motion to hold a follow-up called board meeting before December 1, 2018 to further review the proposed changes.
- h. Healthcare Collaborative Committee- after discussion, the board approved the proceeding of the Healthcare Collaborative Committee.
